ORDINANCE NO. 12 S. 2013

AN ORDINANCE AUTHORIZING THE REALIGNMENT OF APPROPRIATIONS IN THE SUPPLEMENTAL BUDGET NO.1 S. 2013

WHEREAS, Section 336 of the Local Government Code of 1991 states:

Section 336. Use of Appropriated Funds and Savings. Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approve annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

WHEREAS, the realignment of appropriation from one item to another is hereby requested because some projects in the approved City Supplemental Budget No.1 under City Ordinance No.4 S.2013 funded by the 20% Development Fund were found not feasible for implementation because of some technical considerations based on final evaluation and assessment of City Engineering Office.

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod in Session assembled:

SECTION 1. TITLE. This Ordinance shall be called "An Ordinance Authorizing the Realignment of Appropriations in the Supplemental Budget No.1 S.2013"

SECTION 2. REALIGNMENT. The realignment of appropriation in the Supplemental Budget No.1 S.2013 is hereby approved and authorized:

AN ORDINANCE AUTHORIZING THE REALIGNMENT OF APPROPRIATIONS IN THE SUPPLEMENTAL BUDGET NO.1 S. 2013

SECTION 3. LEGAL BASIS. Section 336 of R.A. 7160.

SECTION 4. COMPLIANCE. Compliance to all auditing rules, regulations and circulars issued by COA and the Department of Finance shall be strictly complied with by the Officials concerned.

SECTION 5. SEPARABILITY CLAUSE. If for any reason any part of this Ordinance shall be held unconstitutional or invalid other parts thereof which are not affected thereby shall continue to be in full force or effect.

SECTION 6. EFFECTIVITY. This Ordinance shall take effect upon approval of the City Mayor.
