**WHEREAS**, a review of the Supplemental Budget of Barangays Bucal, Concepcion, Maruclap, San Agapito, Isla Verde, Soro-soro, Ibaba and Tabangao Aplaya, all of Batangas City show substantial compliance with the provisions of the Local Government Code of 1991.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.
