RESOLUTION NO. 231 S. 2014

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS
FOR CALENDAR YEAR 2014 OF BARANGAY POBLACION 01 AND
MAHABANG PARANG, ALL OF BATANGAS CITY**

WHEREAS, a review of the Supplemental Budgets of Barangays Poblacion 01 and Mahabang Parang, all of Batangas City show substantial compliance with the provisions of the Local Government Code of 1991.

NOW THEREFORE, be it resolved as it is hereby resolved, to approve and declare operative the Supplemental Budgets for the purpose the amount was appropriated:

1. Barangay Poblacion 01	P 70,000.00
2. Mahabang Parang	214,832.76

RESPONSIBILITY. The execution of the budget and the accountability therefore shall be vested primarily in the Punong Barangay.

COMPLIANCE. Compliance to the provisions of the Budget Operations Manual for LGU's issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through the Punong Barangay and to the City Budget Officer.


