**WHEREAS**, the Secretary of the Sangguniang Panlungsod in her letter, requested for the creation of the following position titles: One (1) Supervising Administrative Officer (SG-22) and One (1) Local Legislative Staff Officer V (SG-22) in the **Office of the Sangguniang Panlungsod** due to the functions of the said office particularly in handling and management of records and archives, and legislative staff supervision;

**WHEREAS**, the Honorable City Mayor in his letter requested for the abolition of position of Administrative Officer I and the creation of the following position titles: One (1) Reproductive Machine Operator (Administrative Aide II), One (1) Bookbinder II (Administrative Aide IV) and Two (2) Administrative Aide I, in the **Office of the City Legal Officer** due to significant increase of litigations being attended to by the said office;

**WHEREAS**, the Honorable City Mayor in his letter requested for the creation of the following position titles: Two (2) Traffic Aide I (SG-3), Two (2) Administrative Aide IV (SG-4) and Two (2) Administrative Aide I (SG-1), in the **Transportation Development and Regulatory Office** due to vast duties and functions of the said office which are vital in providing the City an efficient transport and traffic management system;

**WHEREAS**, the Honorable City Mayor in his letter requested for the creation of the following position titles: One (1) Taxmapping Aide and One (1) Administrative Aide I, in the **Office of the City Assessor** due to continuous process of saturation drive and revalidation of all real property units subject for taxation purposes of the said office. Also as a result of the just concluded GRA, proper and appropriate filing, binding, sorting and safekeeping of the hard records that have been revised is much of their concern.


**NOW THEREFORE, be it resolved, as it hereby resolves, to approve** the Abolition and Creation of Positions of Different Offices in the City Government of Batangas.

**RESOLVED FURTHER**, that compliance to the Budget Operation Manuals for Local Government Units issued by the Commission on Audit and the Department of Budget and Management, and to all auditing rules and regulation and all applicable laws are hereby mandated and shall be the responsibility of the Chief Executive.


