**INCORPORATING THE TWO PROPOSED ORDINANCES OF COUNCILOR AILEEN  
MONTALBO TO THE EXISTING ORDINANCE REGULATING THE ENTRY AND  
SALE OF IMPORTED MEAT AT LOCAL MARKETS IN BATANGAS CITY**

**RESOLVED**, to incorporate the two proposed ordinances of Councilor Aileen Montalbo entitled hereunder to the existing ordinance Regulating the Entry and Sale of Imported Meat at Local Markets in Batangas City.


1. An Ordinance Requiring All Hog Dealers Doing Business in Batangas City to have their Animals Slaughtered in the Batangas City Slaughterhouse and Providing Penalties for Violation Thereof.
2. An Ordinance Prohibiting the Sale of Fresh Meat Within Two Hundred Meter Radius of Any Public Market in Batangas City and Providing Penalties for Violation Thereof.

**RESOLVED FURTHER**, to refer the same to the Committee on Laws, Rules and Regulations for further study, comments and recommendations.


