

**COMMITTEE REPORT**

SUBMITTED BY : JOINT COMMITTEE ON LAWS, RULES AND REGULATIONS AND COMMITTEE ON BARANGAY AFFAIRS

SUBJECT : Ordinansa Bilang 1, Serye 2014 ng Barangay Pallocan Kanturan, Lungsod ng Batangas, "Isang Ordinansa na Nagpapahintulot na Magtaas ng Singil ng Barangay Clearance, Certification at Iba Pang Gawain sa Nasasakupan ng Barangay".

**COMMENTS:**

The said Ordinance was referred to the Committee on Laws, Rules and Regulations and Committee on Barangay Affairs for study, comments and recommendations during the regular session of the Sangguniang Panlungsod on December 1, 2014.

After the referral to the aforementioned committees, the committees reviewed the ordinance and recommended revision to the Sangguniang Barangay of Pallocan Kanturan. The Sangguniang Barangay took appropriate action and revised the ordinance in accordance with the recommendation of the Committees.

The said ordinance now complies with the recommendation of the Committee on Barangay Affairs for its revision and the copy of this ordinance already submitted, bears the recommendation of the committee.

Section 152 of the Local Government Code of 1991 and Article 240 of the IRR grants the power of the Barangay to impose taxes, fees and levies within the territorial jurisdiction of the Barangay.

The said ordinance sets and prescribes the rates of Barangay clearance fees and fees for the use of Barangay-owned properties which are all allowed under the Local Government Code of 1991.

**RECOMMENDATION:**


Finding no legal impediment and having shows its good intention to implement the subject ordinance, the Committee hereby recommends:

1. The adoption of this Committee Report
2. The approval of the Barangay Ordinance
3. This Barangay Ordinance shall not have retroactive effect.
