AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT COVERING THE SUPPLEMENTARY FEEDING PROGRAM, PANTAWID PAMILYANG PILIPINO PROGRAM, KAPIT-BISIG LABAN SA KAHIRAPAN-COMPREHENSIVE INTEGRATED DELIVERY OF SOCIAL SERVICES (KALAHI-CIDSS), SOCIAL PENSION PROGRAM, SUPPLEMENTAL FEEDING PROGRAM AND BOTTOM-UP BUDGETING PROJECTS

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

WHEREAS, DSWD takes protection of the poor and marginalized as its main mission which it seeks to achieve through the implementation of various projects, programs, and activities collectively referred to as "Social Protection";

WHEREAS, the Local Government Units are mandated by law to address the needs of its constituents, empower its people and allow them widest participation in government affairs;

WHEREAS, the City Government intends to address the proverty of its citizens through the implementation of programs, locally generated or in coordination with National Government Agencies;

WHEREAS, the City Government recognizes that the projects being implemented by DSWD are designed to deliver coordinated social protection services and are aimed at addressing proverty;

- 3. Sustainable Livelihood Program
- 4. Kapit-bisig Laban sa Kahirapan-Comprehensive Integrated Delivery of Social Services (KALAHI-CIDSS)
- 5. Social Pension Program
- 6. Supplemental Feeding Program
- 7. Bottom-Up Budgeting Projects
