RESOLUTION NO. 100 S. 2018

**RESOLUTION ENDORSING THE ESTABLISHMENT OF BATANGAS
CITY HIGH SCHOOL FOR THE ARTS**

WHEREAS, Republic Act 6655 otherwise known as the Free Public Secondary Education Act of 1988 provides for the creation of free public secondary education to all the citizens of the Republic of the Philippines and the provision of a Comprehensive and Quality Education;

WHEREAS, Batas Pambansa Bilang 232 also enumerated the duties of the State in providing free public Secondary Education to all qualified citizens of the Philippines;

WHEREAS, on June 1, 2017, the Sangguniang Panlungsod Committee on Education conducted a committee hearing to discuss the request of the Department of Education, Division of Batangas City and other stakeholders to establish a Batangas City High School for the Arts;

WHEREAS, during said committee hearing, the committee finds it necessary to establish a High School for the Arts to broaden the participation of the students in the conservation of historical and cultural heritage in Batangas City;

WHEREAS, the Honorable City Mayor, Local School Board and the Department of Education, Division of Batangas City manifested their full support in the initial plan to assess, evaluate and consequently for the initial operation and establishment of the said School.


