

SUBMITTED BY : COMMITTEE ON LAWS, RULES AND REGULATIONS

SUBJECT : Letter from the City Mayor, Beverley Rose A. Dimacuha requesting for the grant of authority to the City Mayor to purchase vehicles for the use of various offices.

COMMENTS/ RECOMMENDATION:

Referred to the Committee on Laws, Rules and Regulations is the above request for study, comment and recommendation.

A hearing was conducted on January 25, 2018 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were General Services Department Head Ms. Joyce Cantre, Ms. Flora C. Alvarez from OCVAS, Mr. Francisco Beredo of TDRO, Mr. Andrew Brian Deguito and Mr. Mark Macarandang both from CLB, FSI Glenn M. Salazar, FINSP Christian Leo O. Camo and SFO1 Carlo I. Castro all from Batangas City Fire Station, and Engr. Emelita C. Untalan of CEO.

During the committee hearing, it was raised by the General Services Department Head that there are still other request vehicles from other offices. Hence, on February 12 and 19, 2018, the Honorable City Mayor forwarded the said requests to the Sangguniang Panlungsod the grant of authority to the City Mayor to also purchase additional vehicles for the use of other offices.

The purchase of following vehicles is necessary to meet the needs of various offices in their operation and rendering services.

Finding no legal impediment with the above request, and finding that this would be beneficial to the City Government especially to various offices, the Committee recommends:
