



COMMENT / RECOMMENDATIONS:

Referred to the Joint Committee on the Committee on Laws, Rules and Regulations and Committee on Civil Service was the above request for study, comments and recommendation.

A hearing was conducted on February 20, 2018 attended by the Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were Mr. Oliver C. Gonzales of City ENRO and representative from HRMDO Ms. Rufina O. Calapit.

In Resolutions No. 132 and 133 S. 2013 as approved by the Honorable Body, the appointment of Mr. Oliver C. Gonzales as City Government Department Head I was already adopted and confirmed.

According to the representative of HRMDO, there was a findings from the Office of the Provincial Budget that in accordance with Local Budget Circular No. 61 dated March 18, 1996, the position of City Environment & Natural Resources Officer I, SG-25 should be City Government Department Head I. Hence, the position of City Environment & Natural Resources Officer I need to be abolished, and a new position of City Government Department Head I be created in lieu of the same.
