

COMMITTEE REPORT

SUBMITTED BY : THE COMMITTEE ON APPROPRIATIONS

SUBJECT : SUPPLEMENTAL BUDGETS FOR CALENDAR YEAR 2018 OF DIFFERENT BARANGAYS, ALL OF BATANGAS CITY.

COMMENT / RECOMMENDATIONS:

The supplemental budgets submitted for review contains the necessary documents and action taken by the Office of the City Budget Officer, as follows:

- (1) Certified Statement of Funding Sources, certified by the Brgy. Treasurer (Supplemental Budget Preparation Form No.1).
- (2) Statement of supplemental Appropriation (Objects of Expenditures) – prepared by the Barangay Treasurer and attested by the Punong Barangay (Supplemental Budget Preparation No.2).
- (3) Barangay Appropriation Ordinance approving the Supplemental Budget.
- (4) Letter of the Punong Barangay submitting the budget for review to the Sangguniang Panlungsod.
- (5) Stamped Mark of the preliminary review done by the Office of the City Budget Officer.
- (6) Letter of the City Budget Officer addressed to the SP recommending favorable action on the barangay Budget.

After a review of the said supplemental budgets pursuant to Section 333 of the LGC of 1991 and article 425 of the IRR, the Committee finds the supplemental budgets in accordance with law. Further, the aforementioned Supplemental Budgets of Barangays Poblacion 01, Poblacion 02, Poblacion 03, Poblacion 17, Poblacion 18, Poblacion 20, Poblacion 22, Balagatas, Balete, Banaba Center, Banaba East, Banaba West, Bolbok, Kumintang Ilaya, Libjo, Mabacong, Mahabang Dahilig, Mahacot Silangan, Malitam, Maruclap, Pagkilatan, Paharang Silangan, Pallocan Silangan, Pinamucan Proper, Pinamucan Silangan, San Agapito Isla Verde, San Andres Isla Verde, Sto. Niño, Tabangao Ambulong, Tabangao Dao, Talahib Pandayan, Talumpok Silangan, Tinga Itaas, Tinga Labac and Tulo, all of Batangas City have passed the preliminary review by the City Budget Office and the same were favorably endorsed by the City Budget Officer.
