**RESOLUTION NO. 85 S. 2018**

**RESOLUTION COMMENDING VARIOUS AGENCIES AND AUTHORITIES FOR

**WHEREAS**, on February 28 2018, a vehicular accident in Barangay Libjo resulted to very serious traffic and safety situation endangering lives of commuters, pedestrian, community and properties in the area;

**WHEREAS**, the vehicular accident involved the collision of two (2) Lorrie Trucks, one of which is loaded with diesoline that leaked in the said area;

**WHEREAS**, the said involved authorities, agencies, organizations and public: (1) Sangguniang Barangay of Libjo – led by its Barangay Chairman Nilo Agno; (2) Batangas City Fire Station – Bureau of Fire Protection; (3) City Disaster Risk Reduction Management Office led by Mr. Rodrigo Dela Roca; (4) Joel Chavez Corporation; (5) Triskelion Rescue and Emergency Assistance Team (TREAT); (6) Triskelion Libjo Community Members; and (7) BLADE Motoriders Club, promptly mobilized their resources, equipment and men in response to the serious situation in the area;

**WHEREAS**, the swift and effective concerted action of the aforementioned groups, public and private, resulted to the early solution of the impending crisis posed by the accident;

**WHEREAS**, it is only fitting and proper to commend the aforesaid groups for their earnest efforts and efficiency.
