Referred to the Committee on Barangay Affairs for further study comments and recommendations

Sec. 152 article 3 subparagraph (b) of R.A. 7160 provides

(b) Service Fees or Charges - barangays may collect reasonable fees or charges for services rendered in connection with the regulation or the use of barangay-owned properties or service facilities such as palay, copra, or tobacco dryers.

The Barangay local government unit aims to collect a fee of two to four thousand pesos for the commercial establishments within its territorial jurisdiction in exchange for the collection of garbage wastes generated by these commercial establishments. Such fee covers the expenses that will be curtailed in the operation of the garbage collection and the committee finds the fee to be "reasonable" as described in the code.

SEC. 153. Service Fees and Charges. - Local government units may impose and collect such reasonable fees and charges for services rendered.

Finding no legal impediment and having shown its good intention to implement the subject ordinance, the committee hereby recommends:
