

**COMMITTEE REPORT**

SUBJECT : SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2018 OF VARIOUS  
BARANGAYS IN BATANGAS CITY

**COMMENT / RECOMMENDATIONS:**

The supplemental budgets submitted for review contains the necessary documents and action taken by the Office of the City Budget Officer, as follows:

- (1) Certified Statement of Funding Sources, certified by the Brgy. Treasurer (Supplemental Budget Preparation Form No.1).
- (2) Statement of supplemental Appropriation (Objects of Expenditures) – prepared by the Barangay Treasurer and attested by the Punong Barangay (Supplemental Budget Preparation No.2).
- (3) Barangay Appropriation Ordinance approving the Supplemental Budget.
- (4) Letter of the Punong Barangay submitting the budget for review to the Sangguniang Panlungsod.
- (5) Stamped Mark of the preliminary review done by the Office of the City Budget Officer.
- (6) Letter of the City Budget Officer addressed to the SP recommending favorable action on the barangay Budget.

After a review of the said supplemental budgets pursuant to Section 333 of the LGC of 1991 and Article 425 of the IRR, the Committee finds the supplemental budgets in accordance with law. Further, the aforementioned Supplemental Budget of Barangays Poblacion 23, Poblacion 8, Poblacion 11, Poblacion 14, Poblacion 16, Poblacion 19, Gulod Labac, Mahakot Kanluran, Malibayo, Pinamucan Ibaba, Sampaga, San Miguel, Talahib Payapa, Soro-Soro Karsada and Wawa, all of Batangas City have passed the preliminary review by the City Budget Office and the same were favorably endorsed by the City Budget Officer.

In view of the foregoing, the Committee hereby recommends:

- (a) the adoption of the Committee Report; and
- (b) approval of the resolution hereto attached.
