**A RESOLUTION NOMINATING COUNCILOR ARMANDO C. LAZARTE TO THE
PEOPLE’S LAW ENFORCEMENT BOARD OF BATANGAS CITY**

WHEREAS, it is mandated by law that there shall be a People’s Law Enforcement Board for every city, municipality and each of the legislative districts in a city for the maintenance of peace and order in the locality being the body which has the jurisdiction to hear and decide citizen’s complaints or cases against erring policemen;

WHEREAS, Section 43 of RA 6975 provides for the composition of PLEB one of whom is any member of the Sangguniang Panlungsod chosen by his respective Sanggunian;

WHEREAS, Councilor Armando C. Lazarte, being the chairman of the Committee on Peace and Order and Public Safety of the Sangguniang Panlungsod, is hereby nominated to the People’s Law Enforcement Board;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to nominate as it hereby nominates, Councilor Armando C. Lazarte to the People’s Law Enforcement Board (PLEB) of Batangas City.
