**RESOLUTION NO. 121 S. 2013**

**APPROVING AND DECLARING OPERATIVE THE SUPPLEMENTAL BUDGETS FOR  
CALENDAR YEAR 2013 OF BARANGAYS POBLACION 3 – SK AND STO.  
DOMINGO - SK, BOTH OF BATANGAS CITY**

**WHEREAS**, a review of the Supplemental Budgets of Poblacion 3 – SK and Sto. Domingo – SK, both of Batangas City shows substantial compliance with the provisions of the Local Government Code of 1991.

**NOW THEREFORE**, be it resolved, as it hereby resolves, to approve and declare operative the following Barangay Supplemental Budgets for the purposes the amounts were appropriated:

1. Poblacion 3 – SK	P	176,816.70
2. Sto. Domingo – SK		189,333.10

**RESPONSIBILITY.** The execution of the budgets and the accountability therefore shall be vested primarily in the Punong Barangay.

**COMPLIANCE.** Compliance to the provisions of the Budget Operations Manual for LGUs issued by the Department of Budget and Management and Commission on Audit and to all auditing rules and regulations are hereby mandated.

**EFFECTIVITY.** The approved Supplemental Budgets of each barangay shall take effect upon its approval by the Sangguniang Barangay concerned or on the date fixed in the Barangay Ordinance as provided in Article 416 IRR and Section 332 LGC.




