## RESOLUTION NO. 258 S. 2013

## AUTHORIZING THE IMPLEMENTATION OF PUBLIC FINANCIAL MANAGEMENT IMPROVEMENT PLAN FOR CALENDAR YEAR 2014

WHEREAS, as setforth in the 1987 Philippine Constitution and in the Local Government Code of 1991, it is the State's policy to ensure that the territorial and political subdivisions of the State enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals.

WHEREAS, toward this end, the State shall provide for a more responsive and accountable local government structure instituted through a system of decentralization whereby local government units (LGUs) shall be given more powers, authority, responsibilities and resources.

WHEREAS, for the LGUs to discharge these expanded fiscal, planning and regulatory powers and functions resulting from decentralization, there should be in every LGU an accountable, efficient and dynamic organizational structure and operating mechanism that will meet the priority needs and service requirements of its communities.

WHEREAS, Public Financial Management (PFM) is a system of rules, procedures and practices for government to manage public finances. It encompasses budgeting, accounting, auditing, cash management, management of public debt, revenue generation and public reporting on public sector financial operations. This city has an organized FFM Team to assess and improve the city's FFM systems.

WHEREAS, the PFM Team prepared PFM Improvement Plan for Calendar 2014 to help sustain the culture of good governance, fiscal transparency and accountable leadership that the city administration stands for.
