#### **DISCUSSIONS**

In this hearing, Dra. Ria Concepcion Aguda and Mrs. Liceria Garcia of City Health Office (CHO) gave a background and overview of the subject. They also discussed the importance of all basic immunization for all infants and children to protect them against more diseases and keep other children safe by eliminating or greatly decreasing dangerous diseases that used to spread from child to child.

Infants are particularly vulnerable to infectious disease, that's why it's important to protect them through immunization to give them a healthy start into life.

The committee scrutinized the title of this ordinance and ensures that every suggestions are incorporated to improve further the subject.

#### **FINDINGS**

After extensive discussion, the committee and Sangguniang Panlungsod Members finds that basic immunization for infants and children up to five (5) year old in Batangas City is a proven way to prevent and eliminate life-threatening infectious diseases around the world. A person that has been vaccinated becomes immune or resistant to an infectious disease because vaccines stimulate the body's own immune system to give optimal protection against infections. Hence, Batangas City Government ensures that all vaccines needed is provided by the Department of Health through the services of City Health Office.
