"BAC RESOLUTION NO. 2021-395

**RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF FOOD SUPPLIES FOR USE OF THE OFFICE OF THE CITY VETERINARY AND AGRICULTURAL SERVICES, BATANGAS CITY**

- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;
- WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to Corona Virus Disease 2019;
- WHEREAS, as per IATF resolution, Batangas City is still under the General Community Quarantine until August 31, 2021;
- WHEREAS, Batangas City Government intends to procure Food Supplies (Wet and Dry) charged under General Fund (Cash Advance) as requested by the Office of the City Veterinary and Agricultural Services for the conduct of their Mobile Kitchen Activity/Feeding Programs to various barangays of Batangas City, especially those that are deeply affected by the continuous surge of COVID19;
- WHEREAS, Batangas City, under the General Community Quarantine is still experiencing PANDEMIC with a recent spike in the numbers affected by the Corona Virus, resulted to significant adverse impact to Batangas City residents including movements limitations, unemployment, thereby making it impossible to buy their primary staple, hence the move of the City Government thru the Office of the City Veterinary and Agricultural Services to give-out/provide quality/healthy meals to Batangas City residents directly affected by this pandemic;
- WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;
- WHEREAS, upon canvass of these goods, it appearing that the price offered by the **OCVAS MULTI-PURPOSE COOPERATIVE** with business address located at Bolbok, Batangas City hereunder enumerated was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **OCVAS MULTI-PURPOSE COOPERATIVE** for the Supply and Delivery of Food Supplies in the grand total amount of **P588,813.00** to wit.
