RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF PREPAID LOAD AS REQUESTED BY CITY HEALTH OFFICE

WHEREAS, Batangas City Government intends to procure Prepaid Cards/Load with approved Purchase Request (PR) Nos. 14419 charged under General Fund dated April 05, 2021 to be used in the Temporary Health Facilities of Batangas City Government as requested by City Health Office;

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) as per approved authority. Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, upon canvass of these goods, it appearing that the price offered by **TRADEMARKETEERS MARKETING INC.** with business address located at D. Silang St., Poblacion 14, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;
