**Procurement for the Solid Waste Hauling Transport & Final Disposal to DENR Accredited Landfill Facility for the period covering April 01, 2021 to November 30, 2021.**

The **Batangas City Government** through the Office of the City Mayor intends to apply the sum of **Eighty-Six Million Nine Hundred Three Thousand Six Hundred Eighty Five Pesos and Ninety-Nine Centavos (Php 86,903,685.99)** being the Approved Budget for the for the Project Reference No. BAC-PG-00013-21. Bids received in excess of the Approved Budget for the Contract shall be automatically rejected at Bid Opening.

The Batangas City Government now invites Bids from eligible Bidders for the **Solid Waste Hauling Transport & Final Disposal to DENR Accredited Landfill Facility**. The Contract duration is for a **period of Eight Months**. Bidders should have completed **(5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184. Interested bidders may obtain further information from **Bids & Awards Committee (BAC) Secretariat/TWG** and inspect the Bidding Documents at the address given below from **Monday to Friday at 8:00 a.m. to 5:00 p.m.**

A complete set of Bidding Documents may be purchased by interested Bidders on **February 09, 2021-March 02, 2021** upon payment of a non-refundable fee in the amount of **Fifty Thousand Pesos (Php 50,000.00)**, payable to the Batangas City Treasurer’s Cashier.

The City Government of Batangas will hold a Pre-Bid Conference open to all interested parties on **February 16, 2021 at 09:00 a.m.** at the Sinsayan Lounge Batangas City Sport Coliseum. Only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-Bid Conference.

The Bidding Documents shall be received personally by the prospective bidders or his authorized representative.

Bids and eligibility requirements must be delivered to the address below on or before **March 02, 2021 at 08:30 a.m.** Late Bids shall not be accepted. All bids must be accompanied by a Bid Security in any of the following form:

The City Government of Batangas reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
