

**Invitation to Bid No. 184-22**

**Republic of the Philippines  
Batangas City**

**Procurement for the Ecological Solid Waste Collection & Transportation Services for new collection areas such as new subdivision and residences & Disposal to DENR Compliant Sanitary Landfill Facility for the period covering July 17, 2022 to December 31, 2022.**

The **Batangas City Government** through the Office of the City Mayor intends to apply the sum of **Twenty Nine Million Eight Hundred Eighty Four Thousand Five Hundred Sixty Two Pesos and Forty Centavos (Php 29,884,562.40)** being the Approved Budget for the for the Project Reference No. BAC-PG-00184-22. Bids received in excess of the Budget for the Contract shall be automatically rejected at Bid Opening.

The Batangas City Government now invites Bids from eligible Bidders for the **Ecological Solid Waste Collection & Transportation Services for new collection areas such as new subdivision and residences & Disposal to DENR Compliant Sanitary Landfill Facility for the period covering July 17, 2022 to December 31, 2022**. Bidders should have completed **(10) year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grants similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested Bidders may obtain further information from the Batangas City Government and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested Bidders starting on June 14, 2021 at 8:30 a.m.-5:00 p.m. from the address below and upon payment of a non-refundable fee in the amount of Php 25,000.00.

The City Government of Batangas will hold a Pre-Bid Conference on **June 21, 2022 at 09:00 a.m.** at the address given below and/or through video conferencing/webcasting via zoom meeting. Only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-Bid Conference.

Bids must be duly received by the BAC Secretariat at the address below on or before **July 05, 2022 at 08:30 a.m.** Late Bids shall not be accepted. All bids must be accompanied by a Bid Security in any of the following form:

The City Government of Batangas reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
