ORDINANCE NO. 10 S. 2013

AN ACT CREATING THE INVESTMENT PROMOTION OFFICE, A DIVISION UNDER THE OFFICE OF THE CITY MAYOR AND CREATION OF POSITION TITLES IN THE SAME DIVISION

WHEREAS, It is a declared policy of the state to provide full employment and equality of employment opportunities for all and for this purpose to strengthen and expand the existing employment facilitation service machinery of the government particularly at the local levels.

WHEREAS, Section 454 of R.A. 7160 empowers the Sangguniang Panlungsod to create such offices as may be necessary to carry out the purposes of the city government, and under Section 458 to enact ordinances and appropriate funds for the general welfare of the City and its inhabitants.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE – This Ordinance shall be known and cited as “An Act Creating the Investment Promotion Office Division under the Office of the City Mayor and creation of Position Titles in the Same Division”.

SECTION 2. CREATION – There is hereby created a Division under the Office of the City Mayor to be called “Local Economic and Investment Promotion Office” and creation of four (4) positions in the same division; (a) One (1) Supervising Investment Specialist (SG-22), (b) One (1) Administrative Officer V (SG-18), (c) One (1) Administrative Officer IV (SG-15), and (d) One (1) Administrative Officer II (SG-11).

SECTION 3. ORGANIZATIONAL STRUCTURE – The City Mayor is hereby granted the power to create staff services and appoint the personnel thereof, as may be necessary to carry out the duties, powers and functions of the office created subject to civil service rules and regulations and budgetary requirements.

SECTION 4. RULES AND REGULATIONS – The City Mayor may promulgate and issue rules and regulations for the efficient and effective implementation of this ordinance.

SECTION 5. APPROPRIATION OF FUNDS – A sum sufficient in amount shall be appropriated and included in the incoming supplemental and annual budgets for the City Government to give effect to the creation of the Investment Promotion Office, the creation of positions thereof, and the exercise of the powers, duties and function appertaining thereto.

**AN ACT CREATING THE INVESTMENT PROMOTION OFFICE, A DIVISION

SECTION 6. REPEALING CLAUSE – All ordinances, rules and regulations, orders of parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE – If for any reason any part of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effects.

SECTION 8. EFFECTIVITY – This Ordinance shall take effect upon approval of the City Mayor.
