AN ORDINANCE APPROPRIATING THE AMOUNT OF FORTY ONE MILLION, FIFTEEN THOUSAND, ONE HUNDRED FIFTEEN PESOS AND FORTY FIVE CENTAVOS (P41,015,115.45) FOR THE SUPPLEMENTAL BUDGET NO. 3 OF THE CITY GOVERNMENT OF BATANGAS FOR THE CALENDAR YEAR 2013

WHEREAS, on October 2, 2013 the Honorable City Mayor Eduardo B. Dimacuha submitted to the Sangguniang Panlungsod the proposed Supplemental Budget No. 3 of the City Government of Batangas for the Calendar Year 2013 amounting to P41,015,115.45 for legislation and authorization.

WHEREAS, the funding sources for the Supplemental Budget No. 3 of the City Government comes from the *Miscellaneous Income under Market and Slaughterhouses Fund (P2,201,326.33)*, Share from PCSO for the period June to December, 2012 (*P1,073,159.39*), *Additional Realized Income (P19,180,179.14)*, and *Re-alignment/Reversion Savings on Personal Services (P18,560,450.59)*.

WHEREAS, an examination and analysis of the documentary requirements, the program of appropriations, the objects of expenditure show no legal impediment for the approval of the Supplemental Budget No. 3 of the City Government of Batangas.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE - This Ordinance shall be known and cited as the "Supplemental Budget No. 3 of the City Government of Batangas for the Calendar Year 2013"

SECTION 2. APPROPRIATION OF FUNDS - There is hereby appropriated from the General Fund of the City Treasury the amount of Forty One Million, Fifteen Thousand, One Hundred Fifteen Pesos and Forty Five Centavos (P41,015,115.45) from the *Miscellaneous Income under Market and Slaughterhouses Fund (P2,201,326.33)*, Share from PCSO for the period June to December, 2012 (*P1,073,159.39*), *Additional Realized Income (P19,180,179.14)* and *Re-alignment/Reversion Savings on Personal Services (P18,560,450.59)* which are free from any obligation or encumbrance as certified by the Local Finance Committee, and which are available for Supplemental Appropriation in accordance with the *Objects of Expenditure* as enumerated in the statement of Supplemental Appropriation (LBP Form No. 9).

SECTION 3. COMPLIANCE

3.1 Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.

3.2 Disbursement and expenditures shall comply with the budgetary requirements and limitations provided in Section 324 and Section 325 of R.A. 7160 and all accounting and auditing rules and regulations.

3.3 Compliance to DILG Memorandum Circular No. 2011 – 134 dated September 19, 2011 on full disclosure of local budget and finance, bids and public offerings.


3.4 Compliance to Sections 22, 26 and 27 of R. A. 7160 required.

SECTION 4. REPEALING CLAUSE – All ordinances, rules and regulations, orders of parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


