AN ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATION  
IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD

**WHEREAS**, Section 336 of the Local Government Code authorizes the Local Chief Executive or the Presiding Officer of the Local Sanggunian, by ordinance, to augment any item in the approved annual budget from savings in other items within the same expense class of their respective appropriations.

**WHEREAS**, the Office of the Sangguniang Panlungsod appropriated in the 2014 annual budget amounts under Repair and Maintenance of IT Equipment and Software (-823) and Repair and Maintenance of Other Property Plant and Equipment (-850) which could be the sources of fund for augmentation.

**WHEREAS**, the transfer of appropriation from one item to another is allowed when the purpose of the transfer is to augment any item in the approved annual budget within the same expense class.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod in session duly assembled:

**SECTION I. TITLE.** This ordinance shall be called "ORDINANCE AUTHORIZING THE AUGMENTATION OF APPROPRIATIONS IN THE OFFICE OF THE SANGGUNIANG PANLUNGSOD".

**SECTION II. AUGMENTATION.** The following augmentation in the Office of the Sangguniang Panlungsod is hereby approved and authorized:


**SECTION III. AUTHORITY.** The City Vice Mayor is hereby authorized to sign all documents necessary to effectuate the augmentation.


**SECTION VI. EFFECTIVITY.** This ordinance shall take effect immediately upon approval by the City Mayor.




