WHEREAS, the Boy Scouts of the Philippines, Batangas City Council have been an institution that brings pride to the City of Batangas through different awards and citations obtained by Batangueno scouts on different levels and competitions through scouting activities and achievements;

WHEREAS, the Boy Scouts of the Philippines, Batangas City Council has lined up avenues of service, programs and projects that entails the need for funds through the benevolent consolidation of efforts from the City Government, its constituency and cinema operators to assist and support its operation, continuous implementation of the said activities pursuant to their objectives that will further develop and strengthen boy scouting in the Philippines primarily from its locality;

WHEREAS, the two pesos (Php 2.00) appended on the cinema operators theatre tickets is a clear manifestation of the City Government's support to the Boy Scouts of the Philippines, Batangas City Council and recognition to the need for fund drive in order to ensure its continuous endeavour and attain its noble purpose for the future generations with respect to the absence of the Sangguniang Kabataan;

whereas, Ordinance No. 6 S. 2014 that generated the amount of 402,410.00 proved the invaluable support of the Batangueno people as well as the government and private sector that is SM City Batangas to the Scouting Movement as indeed the generated fund paved way to greatly alleviate the financial challenge that the Boy Scouts of the Philippines, Batangas City Council is experiencing;

WHEREAS, no other organization expressed its intention to apply for a fund drive and that the BSP Batangas City Council is still experiencing financial challenge as manifested on their Resolution No. 4 S. 2015 dated July 31, 2015, it is justifiable that the ordinance of the same nature be enacted;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of Batangas, by virtue of the powers vested in it by law, in session assembled, that:

SECTION 1. TITLE. - An Ordinance Allowing and Requiring All Cinema Owners and Operators Within the Territorial Jurisdiction of Batangas City to Append in their Theater Tickets, Two Pesos (Php 2.00) Covering the Period of November 09, 2015 to May 07, 2016 to Support the Operation, Programs and Activities of the Boy Scouts of the Philippines, Batangas City Council.

SECTION 2. COVERAGE AND AUTHORIZATION. - Cinema owners and operators within the territorial jurisdiction of Batangas City is hereby allowed and required to append in their theatre tickets two pesos (Php 2.00) from the period of November 09, 2015 to May 07, 2016.

SECTION 3. BENEFICIARY. - The proceeds, derived therein shall be donated to the Boy Scouts of the Philippines, Batangas City Council in order to support its operation, programs and activities. In the performance thereof, cinemas shall enter into a Memorandum of Agreement with Boy Scouts of the Philippines, Batangas City incorporating the provisions of this ordinance. In addition, they may be allowed to include, among others, a stipulation on the plausible recognition of this undertaking as a legitimate corporate social responsibility (CSR) program of cinemas.

SECTION 4. FUND SOURCING MECHANISM - Upon the effectivity of this ordinance, moviegoers that intends to purchase theatre tickets for the above stated period may procure tickets according to the authorization stated herein for the said purpose. concerned cinema owners and operators within the territorial jurisdiction of Batangas City are hereby authorized and required to allow cinema goers to have an option of paying the additional P2.00 surcharge. Likewise, all concerned cinema owners and operators within the territorial jurisdiction of Batangas City are hereby authorized and required to transmit and turn-over to the Boy Scouts of the Philippines, Batangas City Council the proceeds collected and account for all such money received and thereafter submit to the City Treasurer of Batangas City Official Receipts and such other pertinent records/documents as may be required in the acknowledgement thereof, subject to existing accounting rules and regulations. The City Treasurer is required to submit the corresponding report to the Sangguniang Panlungsod in connection therewith.

- SECTION 5. INFORMATION TO STAKEHOLDERS. Every cinema owners and operators existing and those that will be established in the City of Batangas within the coverage of this ordinance shall be furnished a copy of this ordinance upon its enactment likewise the Boy Scouts of the Philippines, Batangas City Chapter and Batangas City Treasurer shall be furnished the same for information and guidance.
- **SECTION 6. REPEALING CLAUSE.** All ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended and modified accordingly.
- SECTION 7. SEPARABILITY CLAUSE. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court with competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.
- SECTION 8. EFFECTIVITY CLAUSE. This ordinance shall take effect upon its approval by the Honorable City Mayor and after its publication in a newspaper of general circulation within the province and cities of Batangas.

SUBJECTS

Proposed Ordinance entitled "An Ordinance Allowing and Requiring All Cinema Owners and Operators Within the Territorial Jurisdiction of Batangas City to Append in their Theater Tickets, (Php 2.00) Covering the Period of November 9, 2015 to May 7, 2016 to Support the Operation, Programs and Activities of the Boy Scouts of the Philippines, Batangas City Council. (Authored by Coun. Sergie Rex M. Atienza and Coun. Alyssa Cruz-Atienza)

COMMENTS:

Referred to the Committee on Laws, Rules and Regulations is the above entitled ordinances for study, comments and recommendation.

A hearing was conducted on October 22, 2015 attended by Chairman and members of the Committee and other members of the Sangguniang Panlungsod. Also present were Mr. Ramil S. Borbon and Ms. Eleamar P. Bernal of BSP.

The proposed ordinance is in line with the renewal of City Ordinance No. 6 S. 2014 - An Ordinance Allowing and Requiring All Cinema Owners and Operators Within the Territorial Jurisdiction of Batangas City to Append in their Theater Tickets, (Php 2.00) Covering the Period of November 9, 2014 to May 7, 2015 to Support the Operation, Programs and Activities of the Boy Scouts of the Philippines, Batangas City Council., which was enacted on June 16, 2014.

The committee hearing again revealed that the Boy Scouts of the Philippines still have inadequate and insufficient funding at the moment to cover its operations and expenses due to some constraints on the release of its budgetary allocation from the city government. Therefore, there certainly is a need to assist this organization in the strengthening of its funding.

In view thereof, the committee recommends:

- 1. The adoption of this Committee Report
- 2. To report the Proposed Ordinance for Second and Final reading on the next regular session.

CHAIR (Coun. Alyssa Cruz Atienza): Good afternoon. This is a committee hearing conducted by the Committee on Laws, Rules and Regulations chaired by yours truly, Konsehala Alyssa Cruz Atienza. Nandito rin po ang mga members ng Committee on Laws, Councilor Armando Lazarte,

Councilor Aileen Montalbo, Councilor Claudette Ambida and Councilor Sergie Atienza.

Nandito rin po ang ating mga kasamahan sa Sangguniang Panlungsod, Vice Mayor Doctor Jun Berberabe, Konsehal Blanco, Konsehal Julian Villena and Konsehala Kristine Balmes at Konsehal Dr. Glenn Aldover. Nandito rin po ang ating dating Vice Mayor Joe Tolentino. Councilor Sergie Atienza, you may proceed.

COUN. S. ATIENZA: Thank you Madam Presiding Officer, binabati rin po natin ang ating CSWD officer, Tita Mila Espanola. Before I continue Madam Chair, just a brief background dito sa ating ordinansa, I would just like to thank each and everyone in the Sangguniang Panlungsod for supporting the previous ordinance and at the same time for the effots to re-enact the said ordinance in support to our Boy Scouts of the Philippines Batangas Chapter.

Alam po natin na in the absence of the Sangguniang Kabataan, one of the leading organizations na nagku-cultivate sa values and skills and knowledge ng ating mga kabataan ay ang ating Boy Scouts of the Philippines. Unfortunately, there are some instances, na kung saan ang isang organisasyon ay may mga pangyayari na nalilimitahan ang budget para sa ating Boy Scouts of the Philippines at ito po ay ang tulong n gating pamahalaan. So, at this juncture, Madam Chair, I am submitting the Sections of the Ordinance. At ito po ay walang ipinagkaiba doon sa ating nakaraan. So, sa pagkakataong ito, nais ko po sanang bibigyan ng pagkakataon si Mr. Ramil Borbon para magpahayag ng kanyang sentemyento about the ordinance ay kanyang maipahayag, Madam Chair.

CHAIR: Mr. Ramil Borbon is now recognized.

RAMIL BORBON: Good morning po sa lahat. Huwag po kayong magigitla sa pag banggit namin ng Good Morning, sapagkat sa Boy Scouts po ay walang good afternoon, kahit anong oras ang ginagamit ng Boy Scouts ay Good Morning sapagkat sa Boy Scouts ay walang ibang tinitingnan kungdi ang magandang kinabukasan na nagiintay para sa ating mga kabataan. So, sa inyo pong lahat, the members of the Honorable Sangguniang Panlungsod sa pangunguna n gating Honorable Vice Mayor Doctor Jun Berberabe at sa lahat ng mga bisita at sa mga Boy Scouts na naririto ngayon. For your information, October is a Boy Scout Month. At sa buwan po ng October ay pumipili tayo ng mga Boy Scouts na uupo sa ating gobyerno tulad ng Vice Mayor at members ng Sangguniang Panlungsod.

Gusto ko pong iparating sa inyo na sa buong Pilipinas, it is only Batangas City na nagagawa n gating Boy Officials for a one-week program. Ito po ay ginaya ng ibang lungsod subalit hindi po nila kaya ang kanila lang po ay for one day. Kami po ay nagpapasalamat dahil na-aprub nyo po for last year hanggang nitong April 2015 iyong ating ordianance para sa dalawang piso para sa ating Boy Scouts of the Philippines na talaga naman pong napakalaki ng naitulong. For your information po, the Boy Scouts of the Philippines for the last two years is not receiving any centavo from our City Government through SEF sapagkat naglabas po an gating Office of the City Treasurer at an gating COA na hindi ina-allow ang Boy Scouts of the Philippines na kumuha ng pondo sa SEF. Iyan po ay ating iginalang. Nagkaroon na tayo ng sagot from the Commission on Audit, meron na po taong apela pending sa ating COA at iniintay na lang po natin. Sabi nga po n gating Hon. Councilor Sergie Atienza, Boy Scouts of the Philippines today is the only legitimate organization in the Philippines. In the absence of the Sangguniang Kabataan, Boy Scouts and Girl Scouts of the Philippines are the only legitimate organizations na nabubuhay para sa ating mga kabataan. And herein in Batangas City, we have 35 thousand potential members of the Boy Scouts of the Philippines alone, hindi pa po kasama diyan ang Girl Scouts of the Philippines, and active members of the Boy Scouts of the Philippines as of today is 25 thousand members. Iyan po ang mga nakikinabang dito sa pondo na nakalap natin out of this ordinance which ang na-collect po natin is around four hundred thousand last April. Actually iyan lang po ang pinaiikot ng Boy Scouts of the Philippines. Kung wala po ang inyong ordinansa ay siguro po ay matagal na nagsara ang Boy Scouts of the Philippines. At kami po ay nanghihinayang sa maaaring matutunan ng mga boy scouts, lalo na po ang mga boy scouts na nasa harapan ninyo. We are trying our best to develop their citizenship training, leadership capabilities, values formation at saka po iyong personality development and specially iyong leadership skills nila. Makikita po ninyo, high school pa lamang sila ay tinuturuan na nating magbigay ng serbisyo publiko sa Lungsod ng Batangas. We train them to be future leaders of our country.

Sa buong Luzon ang Batangas City lamang po ang may emergency training kung saan tayo po ay na-responde kasama po ng CDRRMC kapag mayroong sakuna. But of course, hindi po natin isinasabak ng ating mga kabataan sa disaster. Ang magagawa lamang po ng mga kabataan is to

support sa packaging ng mga foods na ipinamimigay sa ating mga naapektuhang kababayan at evacuees. So, ilan po lamang yan sa mga naging pag-suporta n gating Sanggunian sa ating naging bunga sa ordinansa at malugod ko pong ibinabalita sa inyo na sa pamamagitan po sa patuloy na pag-o-operate ng boy scouts, at dahil sa inyo, Batangas City received the 2014 Best Practice for Environment Protection Program and Sustainability, ito po ay awarded sa Boy Scouts of the Philippines, Batangas City at ito po ay awarded sa Taiwan among 119 councils sa Tayo po ang may pinakamagandang programa sa buong Pilipinas. Kalikasan. At ngayong 2015 ay tayo po ang Best Practice among 119 councils sa Public Relation and Communication, ito naman po ang support na ibinibigay ng Smart Communication sa Boy Scouts. Ten thousand free tex message for Boy Scouts of the Philippines for Scouts advisory sa ating mga members.

Higit sa lahat, malugod ko pong ibinabalita sa inyo na sa pamamagitan din po ng tulong ng Sangguniang Panlungsod, sa kasalukuyan ay ngayong darating na November ang Boy Scout po natin na si Scout JB from Saint Bridgets College will represent the Philippines in the Most Outstanding Boy Scout ng buong Asia sa Pacific Region. This is the first time that the Boy Scout from Batangas City will represent the Philippines in the Asia Pacific. Iyon lamang po at maraming salamat sa inyo.

CHAIR: Maraming salamat po Mr. Ramil Borbon. Sir tanong ko lang po, for the year 2014, magkano po ang na-generate na income tungkol sa ordinansang ito?

COUN. S. ATIENZA: May I answer the querry Madam chair?

CHAIR: Yes, Councilor Atienza.

COUN. S. ATIENZA: Madam chair, sa November 2014 nakalikom po tayo ng 32,242.00; December 2014 - 86,238.00; Jan. 2015 - 74,078.00; February 2015 - 45,190.00; March 2015 - 64,662.00; April - 90,146.00 at yon pong May dahil hanggang May 7 lamang ay nakalikom ng 9,754.00 at ang total po ay 402,410.00.

If I may clarify Madam chair, nagpapasalamat po ang ating Boy Scouts of the Philippines sa ating pamahalaang lungsod, pero siguro ang isa pang dapat pasalamatan din ng Boy Scouts of the Philippines ay ang ating SM City Batangas. Sana po ay the Boy Scouts of the Philippines Executive Council could sponsor a Resolution at siguro kami rin po, ang Sangguniang Panlungsod ay makakapag-recognize din expressing sa gratitude sa pakikipagtulungan ng SM Batangas at lalo't higit ang nararapat na pasalamatan ay ang taong bayan na nanood ng sine, ano po. I just want to clarify na ang ordinansang ito ay hindi mandatory, ito po ay optional. Pwede pong hindi mag-donate ng two pesos, kaya po dapat nating pasalamatan ang taong bayan. Marami pong salamat. Wala po tayong binago sa ordinansa, same din po iyong ating mechanism ay tumatakbo na. Maraming salamat po Madam Chair.

CHAIR: Maraming salamat Councilor Sergie Atienza. Anymore questions?

Councilor Lazarte...

COUN. LAZARTE: Magandang hapon po sa ating lahat. Madam Chair, considering na wala namang binago dito sa ordinansa at ito naman ay parang ire-renew lang, ay kung maaari ay ito ay atin nang tapusin kung wala na mga itatanong. Salamat po.

CHAIR: Maraming salamat Councilor Lazarte. Nais ko pong i-recognize ang pagdating n gating hepe ng kapulisan si Sir Allen Co. Magandang hapon po. Kung wala na pong mga comments tungkol sa nasabing ordinansa, tinatapos na po natin at ipinapasa ko po ang chairmanship sa Committee on Social Welfare and Development. Maraming salamat po.
