WHEREAS, on March 17, 2016, the Honorable City Mayor Eduardo B. Dimacuha submitted to the Sangguniang Panlungsod the proposed Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2016 amounting to TWO MILLION SEVEN HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED NINETY SIX PESOS AND NINETY FIVE CENTAVOS (Php2,742,896.95) for approval and authorization.

WHEREAS, the funding sources for the Supplemental Budget No. 2 of the City Government comes from the Surplus - General Fund Market and Slaugterhouses;

WHEREAS, an examination and analysis of the documentary requirements, the program of appropriations, and the objects of expenditure show no legal impediment for the approval of the Supplemental Budget No.2 of the City Government of Batangas.

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE - This Ordinance shall be known and cited as the "Supplemental Budget No. 2 of the City Government of Batangas for Calendar Year 2016".

SECTION 2. APPROPRIATION OF FUNDS - There is hereby appropriated from the General Fund of the City Treasury the amount of **TWO MILLION** SEVEN HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED NINETY SIX PESOS AND NINETY FIVE CENTAVOS (Php2,742, 896.95) from Surplus General Fund -Market and Slaughterhouses which is free from any obligation or encumbrance as certified by the Local Finance Committee, and which is available for Supplemental Appropriation in accordance with the Objects of Expenditure as enumerated in the statement of Supplemental Appropriation (LBP Form No. 10).

SECTION 3. COMPLIANCE

- 3.1 Any change in the budget shall be in accordance with the provision of Section 321 of the Local Government Code of 1991.
- 3.2 Disbursement and expenditures shall comply with the budgetary requirements and limitations provided in Section 324 and Section 325 of R.A. 7160 and all accounting and auditing rules and regulations.
