WHEREAS, the Colegio ng Lungsod ng Batangas, as higher educational institution, adheres to the rules, orders, rules and regulations mandated by the Commission on Higher Education (CHED);

WHEREAS, Ordinance No. 31, S. 2016 gives a representative from CHED a seat in the Colegio ng Lungsod ng Batangas Board of Trustees (BOT) as per CHED Memorandum Order (CMO) No. 32 S. 2006;

WHEREAS, CMO No. 42 S. 2016 amended CMO No. 32 S. 2006 thereby removing representative from CHED from the composition of the Board of Trustees in every Local College and University;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled that:

SECTION 1 - Section 2 of Article II of Ordinance No. 31 Series of 2016 is hereby amended to read as follows:

#### "Article II - BOARD OF TRUSTEES (BOT)

SECTION 2. COMPOSITION OF BOARD OF TRUSTEES (BOT) - The Board of Trustees of the Colegio ng Lungsod ng Batangas shall be composed of the Local Chief Executive as Chairman, the College President as Vice Chairman and six (6) members compose of:

- The President of the CLB Faculty Association;
- The President of the CLB Supreme Student Government/Council;
- The President of CLB Alumni Association;
- · The Chairman of Sanggunian Committee on Education;
- A Representative from Association of Local
