ORDINANCE NO. 2 S.2018

AUTHORIZING THE CITY GOVERNMENT THROUGH ITS CHIEF EXECUTIVE TO EXERCISE THE POWER OF EMINENT DOMAIN FOR THE EXPROPRIATION OF PRIVATE PROPERTY IN BARANGAY ALANGILAN, BATANGAS CITY FOR GRAND TERMINAL EXPANSION AND OTHER PURPOSES

COMMITTEE ON LAWS, RULES AND REGULATIONS

WHEREAS, Section 19 of the Local Government Code authorizes the local government through the Chief Executive to exercise the power of eminent domain by taking private property for public use upon payment of just compensation;

WHEREAS, it has become necessary to make expansion of the existing Grand Terminal of the buses and other transportation facilities in Barangay Alangilan, Batangas City and enter the property more particularly described as Lot 2671-B covered by Transfer Certificate of Title No. T-43518 and Tax Declaration No. 0025-01002 in the names of Melecio Nua and Melody Nua and such other properties of other persons as may be necessary for the aforesaid purpose;

WHEREAS, it is a condition before the taking of the property may be exercised, an amount equivalent to 15% of the fair market value of the property as stated in its current declaration be deposited with the proper court;

WHEREAS, the taking of the property for expansion purposes will ease the traffic congestion in Batangas City area and will continue to greatly benefit the public;

NOW THEREFORE, the Sangguniang Panlungsod in session assembled, ordains and decrees:

SECTION 1. TITLE - This ordinance shall be called "An Ordinance Authorizing the City Government through Its Chief Executive to Exercise the Power of Eminent Domain for the Expropriation of Private Property in Barangay Alangilan, Batangas City for Grand Terminal Expansion and Other Purposes.

SECTION 2. EMINENT DOMAIN - The City Mayor, in the name of the City Government, is hereby authorized to exercise the power of eminent domain and for this purpose to commence and file with the proper court the necessary action for expropriation of the aforementioned property and such other property of other persons as may be necessary for the purpose of expanding the Grand Terminal within the immediate vicinity.

SECTION 4. EFFECTIVITY - The Ordinance shall take effect immediately upon approval by the City Mayor.

The subject request for the expropriation ordinance was referred to the Committee on Laws, Rules and Regulations for its consideration during the Regular Session on February 27, 2018. The Committee held a hearing on April 13, 2018 and in attendance were the following:

FINDINGS:

During the committee hearing, the Committee finds that it is necessary to expropriate the said property for the expansion of existing Grand Terminal and other transportation facilities in Barangay Alangilan, Batangas City.

It was also reiterated that the expansion purposes will ease the traffic congestion in Batangas City area and will greatly benefit the public.
