ORDINANCE NO. 29 S. 2019

AN ORDINANCE GRANTING A FRANCHISE TO COMMONGAMES CORPORATION TO BROADCAST LIVE AND DATA STREAMED COCKFIGHTING ACTIVITIES AND DERBIES AT COMMERCIAL ESTABLISHMENTS AND TO ESTABLISH, OPERATE AND MAINTAIN OFF-SITE COCKPIT BETTING STATION WITHIN THE JURISDICTION OF THE CITY OF BATANGAS

WHEREAS, the Sangguniang Panlungsod of Batangas City, by express provisions of Republic Act 7160, is authorized to regulate, issue license and grant franchise to private entity/s for the establishment, operation and maintenance of cockpits, to regular cockfighting activities and breeding of fighting cocks within its territorial jurisdiction, provided that existing rights should not be prejudiced;

WHEREAS, Commongames Corporation was found to be qualified as franchise holder to cater to the needs of owners, operators and promoters of cockfighting;

WHEREAS, pursuant to the Games and Amusement Board (GAB) continuing regulatory powers over all aspects of cockfighting as provided in P.D. No. 1802 (Creating the Philippine Gamefowl Commission), in relation to E.O. No. 149 (Streamlining the Office of the President) that were devolved to the LGU's through Sec. 447 (a) (3) (v) of R.A. No. 7160 (Local Government Code of 1991), it granted Commongames Corporation authority to take live coverage of cockfights and live stream the same, subject to the terms and conditions stated therein;

WHEREAS, in view of today's modern technology, the City of Batangas recognizes that cockfighting may be viewed in different social media platforms for a fee, through the internet or live-streaming wherein the end-user is situated in another location;

WHEREAS, upon consideration of the application of Commongames Corporation, the City of Batangas, hereby finds no legal impediment to the grant of franchise for the live streaming, broadcasting or other forms of transmission of cockfights and any and all betting on cockfighting through the telephone, internet and other electronic machines/means such as

short messaging, mobile and desktop applications and similar platforms and collect fees for such purpose in commercial establishments within the City of Batangas:

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Batangas, in session assembled, THAT:

SECTION 1. Nature, Scope, Grant of Franchise. - Subject to the provisions of applicable laws, rules and regulations, a franchise to broadcast live and date-streamed cockfighting activities and derbies at commercial establishments such as bars, club, restaurants, common places and the like, within the City of Batangas;

The location where the grantee intends to broadcast and live stream cockfighting activities and to establish, operate and maintain off-site cockpit betting stations, shall be located and operated only within appropriated areas as prescribed by zoning laws and applicable ordinances. No establishment may be operated and maintained within the radius of two hundred (200) lineal meter from any existing elementary and high school buildings and churches.

SECTION 2. Declaration of Franchise - Unless sooner revoked or cancelled, this franchise shall be valid for a period of ten (10) years commencing from the effectiveness of this Ordinance with the option on the part of the Grantee to renew the same for a similar period and subject to the approval of the Sangguniang Panlungsod.

SECTION 3. Authority of the City Mayor. - The Grantee shall apply and secure the required business permit to operate from the Office of the City Mayor and the latter shall have authority to require compliance to all existing laws, ordinances, rules and regulations similarly imposed to all business establishments and impose conditions thereto as are expressly or impliedly

necessary for the protection of the welfare and safety of all persons going or transacting in said commercial establishments.

SECTION 4. Prohibition of Sale, Lease, Usufruct and Transfer of Franchise. - This franchise is non-transferable in character. As such, the Grantee shall not sell, assign, lease, grant the usufruct of or transfer this franchise, including rights and privileges acquired thereunder to any person, natural or juridical, firm or other entities, nor merge with any corporation or individual without prior notice and approval of the Sangguniang Panlungsod. Any unauthorized transfer in any form mentioned shall be considered a violation of the franchise which amount to automatic cancellation/revocation of the same;

Section 5. Mandatory Payment of Taxes and Fees Provisions.

- The Grantee shall be liable to pay all taxes and other fees prescribed by the City of Batangas. The assessment shall be without prejudice to the subsequent impositions as may be adopted or hereafter may be required by law or ordinance. Failure on the part of the grantee to promptly and regularly comply with said tax obligations shall be a ground for the automatic revocation or cancellation of this franchise;

SECTION 6. Other Gambling Activities. - All gambling games of any kind shall at any time be hereby prohibited at the premises of the off-site business operation. The managers or lessee/s of such off-site business and the violators of this provision shall be prosecuted and held criminally liable under the provisions of existing laws.

SECTION 7. Prohibitions against Minors. - No person less than twenty-one (21) years of age shall be allowed in the premises of the off-site at any time. The operator, manager or licensee shall be responsible for strict compliance with these rules and any violation thereof is punishable by suspension or cancellation of this franchise without prejudice to criminal prosecution under existing national and local laws.

SECTION 8. Anti-Fraud Measures/Visitation and Inspection Rights of the City Government Authorized Officials. - Because the subject activity is susceptible to manipulation and there is a need to monitor strictly the timeliness of the cockfights, the Office of the City Mayor shall adopt such measures as to obviate the use of fraudulent means or manipulation in all aspects of off-site cockfighting. Persons employing means or manipulation shall be prosecuted against in accordance with our penal laws as may be warranted by the prevailing circumstances. The measures shall also provide for the authority and inspection rights of authorized City Personnel;

Any breach and/or circumvention of any of the conditions set in this Ordinance, shall be cause for the suspension or revocation of the issued franchise.

SECTION 9. Repealing Clause. - All ordinances not consistent with the provisions of this Ordinance are hereby repealed.

SECTION 10. Separability Clause. - If for any reason any part of this Ordinance shall be held unconstitutional or invalid other parts thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 11. Effectivity Clause. - This Ordinance, upon approval, shall take effect after ten (10) days from publication on a newspaper of general circulation pursuant to Section 59 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.





Chair: Magandang umaga po sa ating lahat ito po ay committee hearing by the Committee on Laws Rules and Regulations patungkol po sa request ng Commongames Corporation for an ordinance granting franchise to, broadcast live and data streamed cockfighting activities and derbies at commercial establishments and to establish, operate and maintain off-site cockpit betting station within the jurisdiction of the City of Batangas. So, ang principal author po nitong ordinance na ito ay ang atin pong Vice Chairman ng Committee on Games and Amusement Councilor Julian Villena and Councilor Boy Dimacuha. So, kaunti pong explanations mula sa ating mga authors, Councilor Julian.

Coun. Julian Villena: Thank you madam chair, ito pong ordinansang ito ay parang pagbibigay ng isang prangkisa sa isang indibiduwal kung saan ay papayagan natin sila na mag-operate ng isang... parang ahhh, parang sa TV lang ito eh, parang may monitor lang, para ba tayong nanonood ng basketball at hindi naman po natin masasabi na ito ay isang sugal. Sapagkat ang Batangas City po ay hindi pumapayag na magkameron dito ng isang sugalan. Para pong yung E-Bingo na ating inaprubahan kung saan ay may mga... naka-register po yung mga naglalaro, halimbawa po eh, bawal po ang minor, bawal po ang eskwela lalo na ho kung menor ito at nagkakameron ho ito ng parang membership I.D. na sila lang yung pwedeng na maglaro kung saan ito ay ilalagay. At kalimitan ho na naglalaro dito, ito ho yung palipasan ng oras ng mga senior citizen, yun ho ang kalimitan dito. Para din hong sa E-Bingo na kumbaga'y nagiging palipasan ng ating mga katatandaan at gusto ko lang pong ilitin na ito ho'y hindi isang sugalan, sapagkat hindi naman ho papayagan ng ating Kgg. na Mayor Honorable Beverley Dimacuha na magkameron ng isang legal na sugalan dito sa Lungsod ng Batangas.

Chair: Councilor Boy Dimacuha.

Coun. Nestor Dimacuha: Thank you, the primary aims of this ordinance to end the proliferation of Electronic Sabong, there are late allegations that there are proliferation of electronic sabong meaning operating illegally. They should take _____ and franchise an ordinance to allow them to stop the proliferation. Now, the purpose of this is yun nga to legalize the operation of E-Sabong and proliferation of illegal electronic sabong.



Chair: Thank you po Councilor Boy Dimacuha, question lang po sa ating mga bisita, saan po kayaa mapapalagay itong ating E-Sabong?

Mr. Norman Fajardo: Good morning po, ako po ulit si Norman Fajardo President ng Commongames Corporation bale po regarding the question ma'am definitely dun po natin ilalagay ito sa mga lugaR na hindi po pinapayagan ng ordinance, malapit sa school, malapit sa simbahan even sa __ meron po kaming mga potential para po dito.

Chair: Isang location lang?

Mr. Norman Fajardo: Hindi sya iisa, kasi actually this is __ so, hindi ko po sinabi na __...(cannot hear the voice clearly)

Chair: Councilor Gerry Dela Roca you're now recognize.

Coun. Gerardo Dela Roca: Thank you very much madam chair, nais ko lang po madam chair marinig. How are you going to differentiate E-Sabong to Global Sabong, i mean so, sa tv lang I think yung last set of sanggunian had already have this permit to one of the operator of this Global Sabong.

Chair: Thank you Councilor Gerry Dela Roca, sir.

Mr. Norman Fajardo: Tulad po ng sinabi ng ating butihing councilors, Councilor Boy Dimacuha, ito po naman ay hindi po isang sugal past time amusement, E-sabong is they conduct studies and __. Now, ang pagkaka-alam ko po sir sa Global po eh nangyayari po ito sa loob ng sabungan so with this time po cover po tayo ng proliferation na nabo-broadcast po ng internet ng mga media na ganito. So, ang pagkakaiba po nito is this __ off-side live streaming na ito po naman ay regulated ng government.

Coun. Gerardo Dela Roca: So, ibig sabihin po ng ating proponent ang E-sabong po ay hindi katulad ng Global Sabong. Ang global sabong po yata ay may pustahan, meron po bang ganu? Ahh, hindi po ako magsasabong kaya hindi ko po alam either yung actual at saka yung global and then ito pong E-Sabong. So, pag sinabi po nating E-Sabong madam chair, ibig sabihin ay nanonood lang po tayo, nanonood lang without involvement of financial ano or magkaiba talaga ito.



Ang global po ba ay parang sa TV lang pero nagsisigawan din ano ho, at may pusta.

Chair: Please answer po sir.

Mr. Norman Fajardo: Ahmm, ang masasabi ko po sir (cannot hear the voice clearly).

Coun. Nelson Chavez: Good morning ho, ako po ay pagminsan ay nagsasabong din pag ako'y nai-imbita ng kaibigan, ang tanong ko po dito dahil nung kami ay may nakitang E-sabong dito po sa may San Pascual ito po ay parang nagbe-bet din, nakuha ng ticket, magbabayad kaya po ito ay parang hindi yung sinasabing hindi ito sugal dahil may kinakabig may natatalo. Yun ho ang pagkaka-alam ko sa E-Sabong ho, ang sa global naman pong sinabi kanina ni Konsehal Gerry ito po ay nasa loob ng sabungan na may TV na pagka nakasa na yung pera pwede na pong __ang tao ay__ pag nagtaasan sila pwede nang pumusta sa 2, yan po ang live sabong ng global. Kaya ito po ay sugal din pero ito po ay legal dahil ito po ay may franchise ano po, hindi po natin ito mai-iwasan dahil ito po ay... yun nga merong franchise kung tayo ay mabibigyan. VM Jun Berberabe: Madam chair, tanong ko lang ho, yung sa global sa loob ng sabungan ano ho, ito pong ina-apply nyo cover nya po ay mga establishments so, pwede sya sa mga restaurants, sa mga bar, kung saan pe-pwedeng mag ingay na parang sa E-Bingo, meron pong isang __ lang so, so pwede po ito sa mga restaurant, so kung Maglalagay kami ng isa__ sa restaurant ibig sabihin doon pupunta sila para... kasi sila ang bibigyan nyo ng franchise kung saka-sakaling, kasi dun po sila magsasabong?

Mr. Norman Fajardo: Tama po yun.



Coun. Oliver Macatangay: Madam chair, good morning po Councilor Oliver Macatangay po, magtatanong lang po, yun po bang E-Sabong yun po ba ay live, sabong live?

Mr. Norman Fajardo: Yes sir.

Coun. Oliver Macatangay: Saan po ito naka-live?

Mr. Norman Fajardo: Manila po.

Coun. Oliver Macatangay: Manila, o parang global rin, so parang parehas din ng global. So, halimbawa po ba ako ay nasa restaurant, papaano po, halimbawa gusto naming manood, gusto naming maglaro, ano po ang gagawin ano po ang proseso halimbawa ay nasa loob kayo ng bar, paano yun may tawagin ng logis, logis o... hindi ano po, gusto lamang naming malaman kung ano ang proseso.

Mr. Norman Fajardo: Actually ito po ang pagkaka-alam ko dyan, kung saan ponglugar yan ang makakapasok lamang po syempre yung hindi minor, unang una hindi minor at mga members lang, tapos pagpasok nyo po sa loob, pwede kayong kumain pwedeng uminom kape habang nag e-enjoy habang nagwa-watch ng sabong live po from Manila, so parang additional past time po sa atin.

Coun. Oliver Macatangay: Yes po, ang tanong ko po, paano po ba yung proseso halimbawa gusto ko pong mag-bet, syempre may mga meron po, so papaano po ang proseso, kukuha ba sila ng ah... papaano sila tataya papaano sila pipili ng manok?

Mr. Norman Fajardo: In general po ang pagkaka-alam ko dito sir, kasi, pasensya na po at hindi ko po nakasama yung sa aking technical, ang pagkaka-alam ko po ano halimbawa mag __ ka may chance ka pong mag-bet.

Coun. Oliver Macatangay: Ano po yun token o money o talagang pera.

Mr. Norman Fajardo: Ticket po ticket, parang lotto outlet.

VM Jun Berberabe: Madam chair dagdag lang po in relation dun kay Councilor....Ito po ba ay parang E-Bingo, kapag tumaya kayo tapos pag nanalo kayo babayaran na rin kayo sa oras na yun pera na rin ang matatanggap nila?

Mr. Norman Fajardo: Yes po, since ito nga po ay live na ipinapalabas, since live naman po yung streaming pwede naman... parang din E-Bingo the moment you raise makukuha nyo rin yung pera.

Coun. Nelson Chavez: Ang pagkaka-alam ko diyan sa machine may tao silang naka... may tao silang nagbibigay ng ticket nagbibigay ng kabig, ganun, may naka-assign silang tao sa...

Mr. Norman Fajardo: Yes sir, parang pinaka-cashier.

Coun. Nelson Chavez: Ang tanong ko diyan, ang global sa atin ay 2 yata ang may hawak sa Manila, ito'y Sagupaan ahhh... kung hindi po ako nagkakamali kay Patrick Antonio at isa ay kay Atong Ang, ang pagkaka-alam ko ditto sa atin sa Sta. Rita ay parang kay Patrick Ang ang Sagupaan. Sino po ang talagang operator nitong ano, sino po ang... syempre bago kayo pumunta rito ay nag-apply kayo sa kanya para ma-apruban yan.

Mr. Norman Fajardo: Yun po, bale po United Association of Cockpit Owners and Operators of the Philippines Inc. sya po ang aprubado ng board.

VM Jun Berberabe: Madam Chair, yun pong tinanong ni Councilor Nelson Chavez, tama po ba United Association of Cockpit Owners and Operators of the Philippines Inc., sir Norman dito po kayo nagsabi?

Mr. Norman Fajardo: Opo.

VM Jun Berberabe: Dito sa United Association, sya po yung pinaka-mother ditto sa... pagdating dito sa inyong ito, UACOOP?

Mr. Norman Fajardo: Yes sir.

VM Jun Berberabe: Salamat po.

Mr. Norman Fajardo: Sila po ang approved ng GAB .

Coun. Lorenzo Gamboa: Good morning po, regarding po dun sa E-Bingo at E-Sabong kaklaruhin ko lang ano ho, kasi pag iyong inisip Electronic Bingo may gamit hong machine yun, pero yung E-Sabong akala ko machine pa rin yun na pipinduting ganun. So, ang E-sabong walang pinagkaibahan sa global kasi live



streaming yan galing kung saang Manila derby yan bago itong sinasabi ninyong E-Sabong ay display din sa TV na manonood ang mga tao which is meron kayong counter diyan kung saan kayo tatayo kung sa dehado o sa llamado. So, wala pong ipinagkaiba sa global ano, so di parang ang nilalabsan ay sugal din.

Mr. Norman Fajardo: Actually sir to be honest hindi ko po masagot kasi hindi ko po kabisado yung sugal.

VM Jun Berberabe: Madam chair, tanong ko lang po, ang global kasi sa loob ng sabungan yung sa inyo po pwedeng ilabas?

Mr. Norman Fajardo: Yes sir, pwede po, on an off-side naman po.

Coun. Julian Villena: Thank you madam chair, sa akin hong pagka-alam yung global yan ho'y sabay na sabay din sa Maynila nasa loob ng sabungan at ang nagiging tema ho dito ang pagpupustahan yan ho'y sigawan, unlike naman ho dito na kukuha ka ng ticket at dun ka tataya ay di siguro'y ipunin mo yun at kung panalo'y... yung sa San Pascual naman ay parang may kahera din kaya lamang ang problema dun ay hindi dumaan sa sanggunian kaya ang ibig sabihin nati'y ito'y isang illegal dahil ito'y walang permit o franchise na isinecure nila sa San Pascual. Parang siguro'y sa salitang Batangenyo ay di dibdib laang ang tinanong dun, yun po.

Coun. Nestor Dimacuha: Dagdag lang ho an oho, gaya ng sinasabi ko, the primary aim is to end the proliferation of electronic sabong so ile-legalize ang electronic sabong ganun din yung illegal cockfighting o yung tupada. So, ito yung magiging legitimate registered sabong ano, so, the very purpose is to end the proliferation of illegal sabong, electronic sabong and legalize the e-sabong by means of new technology we can approach e-sabong. Pero it is also a mere problem di natin pwedeng ikaila yun, kaso nga lang legalize at may permit galing sa Games Amusement Board. So may compliance ito.

Coun. Gerardo Dela Roca: Madam chair, so kanina po sinabi ko hindi ako talaga familiar sa sabong so, ang pinag-uusapan natin electronic sabong, ang global sabong parang sinasabi may pustahan, sigawan ang electronic sabong wala siyang pustahan nandun lang po ang... kung sinuman ang Manalo yun pong namamahala sa palaro ay dun po makukuha ang price. So, medyo may kaunti po



akong disagreement dun sa... itong pagli-legalize sa sabong. Kasi ang sabong po, alam naman natin yung parang saya ang naidudulot na kapustahan sa kapwa kapustahan ay naroroon samantalang itong electronic sabong ay kumbagay dun sa live, kung naa-alala ninyo yung jai-alai, yung jai-alai po may live games, malapit sa school namin dati, so, ibig sabihin ko nagbe-bet ka ng isang game ng isang combination number at lahat ay dun kukuhanin ang price dun sa cashier nila. So, ito pong E-Sabong ay katulad po ng ganun electronic nga lang po siya live na napapanood at kung mananalo ay wala po itong kapustahan, kung mananalo ka panalo and then you get the price from dun po sa nagpapatakbo ng games, so, yun po parang ganito ang sistema nito, yun laang po.

VM Jun Berberabe: Madam chair, siguro po ang ano lang naming dito, kung ito po ay electronic bingo baka ang mangyari dyan magkaroon po ng mga side betting, syempre po ipinapalabas yan, tayong dalawa, tayo nalang ang mag-bet para hindi na natin padaanin dyan sa ano, so dapat baka po kakailanganin natin ang strict monitoring para wala pong mangyayaring side-betting kasi baka po masyadong maging proliferate ang gantong mga games ano at baka habang nanonood, tayong dalawa nalang ang mag bet wag na nating padaanin dyan sa instruction or what ano. So, sana po maiwasan natin ang mga ganito.

Mr. Norman Fajardo: Sir maa-asahan nyo po na sa aming enforcement nang... just to make sure na walang mangyayaring ganyan sa... maglalagay po kami ng strict security measures, mga CCTV mga tao namin and also meron pong membership yan maipapangako po namin na maiwasan po namin yang mga bagay na yan.

Chair: Sir, yun pong ating mga E-bingo ano at saka yung ating mga casino's bawal po ang government employees ano meron po tayong batas. So, dito po sa E-Sabong bawal din po ang government employees?

Mr. Norman Fajardo: Opo.

Chair: Siguro po pwede po nating maidagdag ano po sa ating ordinance ano po sa ating proponent, any question po, Konsehal Nelson Chavez.

Coun. Nelson Chavez: Tatanong ko lang po, itong E-sabong , itong global ito po ay hindi araw-araw ang sabong kung kailan lang ang schedule na dapat sa kanila,



ano po ang mangyayari dito kung kailan lang may laban at kalimitan po dito natatapos ay ala-una, alas dos ng madaling araw kaya po ang magiging isang problema sa inyong mapupwestuhan kung saan po kayo pwesto, kalimitan po yan ay ala-una, ala-dos, alas-tres. Yun nga po, inyo po sanang itatanong kung ano talaga ang schedule para po malaman ng mga magsasabong ang schedule sa inyong mga franchise, yun po sana ay ating malaman lalo pa't ang mga magsasabong natin ay nainom nang kaunti, sana po ang inyong security ay ating higpitano po.

Mr. Norman Fajardo: Yes sir, makakaasa po kayo na gagawin po namin yan.

VM Jun Berberabe: Madam chair may katanungan lang daw po dito, kung ito daw pong mga government employees ay totally ban o may mga araw lang hindi sila pupwede, halimbawa pag holiday naman, weekend naman pupwede po silang maglaro o during office hours lang po sila bawal? Dapat maklaro po natin yan para sa ating mga empleyado.

Mr. Norman Fajardo: Sir kung ano po ang nasa legal at batas yun po ang susundin natin.

Coun. Julian Villena: Pwede ho gang dagdagan yun, alam nyo po lalao na sa live na sabong, ang sabong po ay kino-consider nila as sports yan po yung ahhh... kasi kung ito ho ay bawal alam nyo po ang isang pinakamalakas na magsasabong ay si Patrick Antonio, si Patrick Antonio po ay isang congressman, si Nene Aguilar mayor ng Muntinglupa pero isa ho sa big time na sabungero yan kaya ho ang alam ko ay ang sabong ay kino-consider na sports yan ho ang pinalalabas nila at siguro hindi ho ito katulad ng casino eh, sa casino talagang binabawal talaga ang government employees at napakalaki naman ho nung nakalagay sa mga gate ng casino na bawal at talagang binabawal at kung sakaling mapatunayan na ikaw ay naglaro sa casino ay talagang that is grounds for a... hindi lang po suspension talagang tatanggalin ka, pero sa parte naman ho ng sabungan ay wala pa naman ho akong nalalaman na ipinaghawal sa mga empleyado maliban na lamang ho kung ang empleyadong pupunta ay oras ng trabaho at magsasabong sya sa oras ng trabaho sa tingin ko ho ay talagang bawal ho yun pero kung Sabado't Linggo naman ho ay wala naman hong pagbabawal.

Coun. Oliver Macatangay: Salamat ho madam chair, siguro po sabi nga ng ating bisita ito'y parang susubukan palang. So, kung sakali, sakali na ito po ay matuloy siguro iano nalang natin na... alamin natin kung talagang sila ay lumalabag sa ordinansa ay saka palang po natin sila ipatitigil kung talagang may mga violations. So, para po sa akin di subukan, subukan po natin, dahil sabi nga po ni Konsehal Boy ay marami naman ho diyan na nag o-operate nang wala man lamang permit, walang prangkisa ay napapayagan ay ito naman ay in good faith talagang pong sila'y lumalapit para magkaroon ng prangkisa, ma-legalize ay di para po sa atin ay kung ito naman po ay magbe-benefit ang marami ay di atin pong pag-aralan at payagan, yun lamang po maraming salamat po.

Coun. Nestor Dimacuha: Dagdag po, katulad po ng sabong sa bias ng P.D. 446 in-allow ang cockfighting so naging isang__ at katulad din ng isang local ordinance i-allow din natin ang operation at legalization ng isang __, yun lang hindi tayo pwedeng magpasa ng isang resolusyon (cannot hear the voice clearly), so, this one way of regulating the operation of E-Sabong kasi without the authority from the Sangguniang Panlungsod walang operation, so ito ang magbibigay ng legality sa operation ng e-sabong.

Coun. Oliver Macatangay: Last po, tanong ko lang po, sa buong Pilipinas po ba ay ito po ang kauna-unahan o meron na sa iba.

Mr. Norman Fajardo: Manila po.

Coun. Oliver Macatangay: Ah, meron ng isa so, kung saka-sakali ito ang padalawa sa buong Pilipinas, ah marami na, yun ang tanong ko hindi lamang sa Manila so marami na ang nag o-operate ng ganitong e-sabong, okay yun lang po.

Coun. Julian Villena: Ito naman ho'y kuwan, hindi ibig sabihin na na-Aprubahan natin yung ordinansa ay yun na yun, magko-comply pa rin ho sila marami hong requirements nadadaanan, sa zoning na laang ho ay dapat compliance talaga, hindi po pwede na matapos ma-aprubahan ang ordinansa ay yun na yun, hindi magko-comply ho sila, hindi pwedeng hindi sila magko-comply dun sa lahat ng requirements ng city with regards po dun sa kanilang ina-apply.

Coun. Gerardo Dela Roca: Madam chair, sapagkat ang atin pong gagawin dito ay ordinansa so this is already a law, so dun po sa ating gagawing local ordinance



ay atin pong ilalagay agad yung mga compliance, gagawin po natin yun para hindi na po after passing the ordinance may proseso pa po yan kasi pagkatapos po nito ay tapos na, wala na pong mga compliance na kukuhinan sa ibang department because ____.

Chair: Vice mayor.

VM Jun Berberabe: Sir kung halimbawa po ma-aprubahan itong ordinansang ito, then kukuha po kayo ng mga business permits dun lang po kikita ang city government sa mga mayors permit sa business permit.

Mr. Norman Fajardo: Sa taxes po.

VM Jun Berberabe: Sa mga taxes.

Chair: Any questions po or comments? Kung wala na po maraming salamat po sa inyong pagdalo sa committee hearingna ito ngayong araw, kung wala na po maraming salamat po, so this committee hearing is now adjourned.
