**WHEREAS**, on September 2, 2020, the Honorable City Mayor in her letter, requested for the grant of authority to purchase vehicles for the use of City Disaster Risk Reduction and Management Office;

**WHEREAS**, there is a need to purchase the following vehicles to support the operation and services rendered by the City Disaster Risk Reduction and Management Office;

**NOW THEREFORE**, be it ordained by the Sangguniang Panlungsod in session assembled:

**SECTION 1. TITLE.** - This Ordinance shall be called "Ordinance Authorizing the City Mayor, Beverley Rose A. Dimacuha to Purchase Vehicles for the Use of City Disaster Risk Reduction and Management Office".

**SECTION 2. APPROPRIATION.** - The appropriation for the purchase of various vehicles was hereby approved and authorized:

**One (1) unit Passenger Van**

For use of the City Disaster Risk Reduction and Management Office, Batangas City  
2,755 cc  
Diesel Fed  
4 cylinders

**One (1) unit Multi-purpose Vehicle**

For use of the City Disaster Risk Reduction and Management Office, Batangas City  
2,200 cc  
Diesel Fed  
4 cylinders

**SECTION 3. AUTHORITY.** - The City Mayor is hereby authorized to sign all documents necessary to effectuate the said purchase of vehicles.


