WHEREAS, on September 2, 2020, the Honorable City Mayor in her letter, requested for the grant of authority to purchase vehicles for the use of City Disaster Risk Reduction and Management Office;

WHEREAS, there is a need to purchase the following vehicles to support the operation and services rendered by the City Disaster Risk Reduction and Management Office;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled:

SECTION 1. TITLE. - This Ordinance shall be called "Ordinance Authorizing the City Mayor, Beverley Rose A. Dimacuha to Purchase Vehicles for the Use of City Disaster Risk Reduction and Management Office".

SECTION 2. APPROPRIATION. - The appropriation for the purchase of various vehicles was hereby approved and authorized:

One (1) unit Passenger Van

For use of the City Disaster Risk Reduction and Management Office, Batangas City 2,755 cc
Diesel Fed 4 cylinders

One (1) unit Multi-purpose Vehicle

For use of the City Disaster Risk Reduction and Management Office, Batangas City 2,200 cc Diesel Fed 4 cylinders

SECTION 3. AUTHORITY. - The City Mayor is hereby authorized to sign all documents necessary to effectuate the said purchase of vehicles.
