ORDINANCE NO. 33 S. 2020

AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE BUDGET ALLOCATION OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT ANNUAL INVESTMENT PLAN AND CONTINUING FUND FOR THE YEAR 2020 UNDER LDRRM FUND AMOUNTING TO FOUR MILLION SEVEN HUNDRED THOUSAND PESOS (P4,700,000.00)

SPONSOR: COUN. ALYSSA RENEE A. CRUZ COMMITTEE ON APPROPRIATIONS

WHEREAS, Section 336 of the Local Government Code of 1991 states:

Section 336. Use of Appropriated Funds and Savings – Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another.

WHEREAS, the transfer of appropriation from one item to another is allowed when the purpose of the transfer is to augment any item in the approved annual budget within the same expense class;

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY THAT:

SECTION 1. TITLE. - This Ordinance shall be known and cited as "AN ORDINANCE AUTHORIZING THE REPROGRAMMING OF THE BUDGET ALLOCATION OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT ANNUAL INVESTMENT PLAN AND CONTINUING FUND FOR THE YEAR 2020 UNDER LDRRM FUND AMOUNTING TO FOUR MILLION SEVEN HUNDRED THOUSAND PESOS (P4,700,000.00)".

SECTION 2. REPROGRAMMING. - The said reprogramming was hereby approved and authorized:

SECTION 6. EFFECTIVITY. - This Ordinance shall take effect upon approval of the City Mayor.
