ORDINANCE NO. 37 S. 2020

AN ORDINANCE GRANTING FRANCHISE TO OPERATE EZYGO APPLICATION HOSTING SERVICES FOR THREE (3) YEARS AND PROVIDING EXEMPTIONS FROM THE PROVISIONS OF THE BATANGAS CITY TRAFFIC ORDINANCE OF 2020

SPONSORS: COUN. ALYSSA RENEE A. CRUZ COUN. NESTOR E. DIMACUHA

WHEREAS, PARA Systems-Apps For E-Transport Corp. (PARA SAFE CORP.) is a mobile app developer specializing in the digitalization and automation of all types of transportation in the Philippines;

WHEREAS, LGUs from all over the Philippines have been engaging their services by partnering with them through Franchisees in different LGUs;

WHEREAS, EZYGO Application Hosting Services is the Exclusive Franchisee of PARA Systems-Apps For E-Transport Corp. (PARA SAFE CORP.) and the sole and exclusive technology partner of PARA Traysikel, PARA Bill, PARA Fare, as well as all PARA products in the future;

WHEREAS, in Batangas City, PARA SAFE CORP. is in partnership with EZYGO Application Hosting Services in the implementation of all its tech products and tech services;

WHEREAS, to fulfill its promise of unwavering technology services to the constituents of Batangas City, the PARA SAFE CORP, through the EZYGO Application Hosting Services applies for franchise to operate within the City of Batangas;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of Batangas City, in Session assembled:

SECTION 1. TITLE- This Ordinance shall be called "AN ORDINANCE GRANTING FRANCHISE TO OPERATE EZYGO APPLICATION HOSTING SERVICES FOR THREE (3) YEARS AND PROVIDING EXEMPTIONS FROM THE PROVISIONS OF THE BATANGAS CITY TRAFFIC ORDINANCE OF 2020"

SECTION 2. SCOPE. This ordinance shall cover and apply to all tricycles operated within the territorial jurisdiction of Batangas City.

SECTION 3. FRANCHISE. A franchise for *EZYGO Application Hosting Services* is hereby granted for three years, which shall be renewable upon mutual agreement of the parties under such terms and conditions as may be hereinafter be agreed upon.

AN ORDINANCE GRANTING FRANCHISE TO OPERATE EZYGO APPLICATION HOSTING SERVICES FOR THREE (3) YEARS AND PROVIDING EXEMPTIONS FROM THE PROVISIONS OF THE BATANGAS CITY TRAFFIC ORDINANCE OF 2020

SECTION 4. REGISTRATION WITH EZYGO APPLICATION. Tricycles granted with a franchise by the City Government of Batangas may apply for membership with EZYGO application Hosting Services. Tricycles without franchise may apply and avail of a Tricycle Franchise for free before the Tricycle Franchising Regulatory Committee (TFRC) until March 31, 2021.

For this purpose, the TFRC shall provide additional franchises for new applicants provided that applicants shall pay the appropriate fees required by the Tricycle Franchising ordinance and other related revenue laws only upon their renewal in 2022.

- **SECTION 5. EXEMPTION.** Tricycles registered under EZYGO Application Hosting Services shall be exempted from Article XXXIII, Section 178-184 on Tricycle Routes, Codes and Terminals.
- **SECTION 6. FARE GUIDE.** A minimum fare of twenty-five pesos (P25.00) for the first three kilometers (3km.) distance and an additional P5.00 for every succeeding kilometer shall be charged by the operator from each passenger as provided under Section 4 (k) of the Interim Transportation Regulation of Batangas City.
- **SECTION 7. CANCELLATION OF FRANCHISE.** Violation of any provision of this Ordinance, the Batangas City Traffic Ordinance of 2020, and other related laws and ordinances shall cause the cancellation of the Franchise herein granted.
- **SECTION 8. IMPLEMENTING RULES AND REGULATIONS.** The City Mayor may promulgate and issue Implementing Rules and Regulations for the efficient and effective Implementation of the provision of this Ordinance.
- SECTION 9. SEPARABILITY CLAUSE- If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effects.
- SECTION 10. REPEALING CLAUSE- All ordinances, rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.
- **SECTION 11. EFFECTIVITY-** This Ordinance shall take effect after completion of posting thereof in conspicuous places in Batangas City.

COMMITTEE REPORT

REQUEST FOR ACCREDITATION OF PARA SYSTEM-APPS FOR E-TRANSPORT CORPORATION (PARA SAFE CORP.)

COMMENTS/RECOMMENDATIONS:

The subject request for the passage of an ordinance was referred to the Joint Committee on Laws, Rules and Regulations and Committee on Transportation for its consideration. The Joint Committee conducted a hearing to be enlightened on the proposal of the Applicant and to address their requests.

Present during the hearing are the SP Members, EZYGO & PARA Representatives introducing a Location-Base Mobile App Service which aimed to provide an on-demand ride hailing service of all forms of vehicle-business operations like passenger and cargo transportation, business and leisure usage and lastly delivery and logistics.

The following advantages of adopting PARA Technology are thoroughly discussed by the Applicant and succinctly explained anent the following stipulated to wit:

- 1. Contact Tracing
- 2. Public Transport Operation Control
- 3. Fare Overcharging
- 4. Fare Matrix Enforcement
- 5. Anti-Colorum and Conversion to Colorum to legit tricycle operation
- 6. Traffic Deduction
- 7. More Revenue for Drivers
- 8. Public Safety
- 9. DILG Anti-Obstruction Law-Friendly (Road Clearing)
- 10. Support for Traditional Merchants and Enterprise
- 11. LGU Digital Public Address System

In view of the foregoing, the Joint Committee recommends the following:

- An Approval of the Ordinance granting franchise to operate EZYGO Application hosting services for Three (3) years and providing exemptions from the provision of the Batangas City Ordinance of 2020.
- To grant one-time franchise to all existing colorum tricycles by the Sangguniang Panlungsod through Transportation Development Regulatory Office (TDRO).
