**WHEREAS**, mandated by Republic Act 9994 or the Expanded Senior Citizens Act of 2010 to give full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are integral part of the Philippine society;

**WHEREAS**, each barangay in the City of Batangas has a Senior Citizen Association for which a Chapter President heads the organization;

**WHEREAS**, the current honorarium amounting to Php 1,000 is of great help to each Chapter President, however, the sudden price increase of a senior citizen's basic necessities demands increase for each to fully serve his/her area of responsibility;

**ORDINANCE APPROPRIATING ADDITIONAL ONE THOUSAND FIVE HUNDRED PESOS (PHP 1,500.00) FOR THE HONORARIA OF THE CHAPTER PRESIDENTS OF THE SENIOR CITIZENS IN BATANGAS CITY**

**NOW THEREFORE**, be it ordained by the Sangguniang Panlungsod of Batangas City, in Session assembled:

**SECTION 1. TITLE.** This Ordinance shall be known as "An Ordinance Appropriating Additional Honorarium for Senior Citizen Chapter Presidents."

**SECTION 2. STATEMENT OF POLICY.** Section 16 of Republic Act No. 7160 provides that every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers, necessary and appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare. And, as government development programs are now focused on countryside development, particularly on the improvement of quality of life in the barangays anchored on social equity, by providing the poorest of the poor with access to basic services for survival, it is likewise the policy of the City Government to recognize the contribution of the volunteer workers who serve as frontliners in the delivery of basic services.

**SECTION 3. SCOPE AND COVERAGE.** This Ordinance shall cover the Chapter Presidents of the Senior Citizens in 105 barangays in Batangas City.

**SECTION 4. DEFINITION OF TERMS.**

- a. **Chapter President** - the elected president for the time being of a Chapter of the Association, or the person chosen by the members of the chapter to be the principal member of that Board.
- b. **Honorarium** - token payment made to bestow recognition to an individual for services they perform, for which payment is not required.
- c. **Senior Citizens** - an elderly person, especially one who is retired and living on a pension.

**SECTION 5. FUNDING SOURCE.** The funding source necessary to implement this ordinance shall be provided in the Annual Investment Plan of the current year, of the city.

**SECTION 6. SEPARABILITY CLAUSE.** If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

**SECTION 7. EFFECTIVITY.** This Ordinance shall take effect upon approval of the City Mayor.



### **COMMITTEE REPORT**

*RESOLUTION NO. 03 SERIES 2022 CITY ELDERLY OF BATANGAS INC*

#### **BACKGROUND:**

The subject is a letter from the City Mayor Beverley Rose A. Dimacuha re: attached Resolution No. 03 Series 2022 of the City Elderly of Batangas Inc. requesting additional Php 1,500.00 for the honorarium of each Chapter President of the Senior Citizens. This was referred to the Committee on Appropriations for its consideration during the Regular Session last July 25, 2022. The Committee held a hearing on August 1, 2022 and in attendance were the following:

Vice Mayor Atty. Alyssa Renee A. Cruz; Members of the committee headed by Hon. Karlos A. Buted and its members: Hon. Nestor E. Dimacuha, Hon. Isidra M. Atienza, Hon. Lorenzo A. Gamboa, Jr., and Hon. Nelson J. Chavez. Also present were Sangguniang Panlungsod Members: Hon. Hamilton G. Blanco, Hon. Andrea F. Macaraig, Hon. Michael Villena, and SK Federation President Hon. Marjorie A. Manalo.

Proponents were also present namely, Office of the Senior Citizens Affairs (OSCA) Chairperson Mrs. Josefina Dangal; OSCA Staff: Ms. Nila Achico; Vice President of the City Council for the Elderly of Batangas City (CCE): Ms. Virginia Clemeno; Board of Directors of CCE: Ms. Beatriz Untalan and Mr. Cesar Ramos. Also present were City Treasurer Ms. Arminda Madayag, City Budget OIC Mr. Manolo Perlada, City Planning and Development Coordinator Ms. Gilda Godoy, and Ms. Felicidad Torino, a representative from the City Accounting Office.

#### **FINDINGS:**

The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and suggested necessary matters:

1. Main concern of the committee is the availability of the fund and where shall it be taken from;
2. As per City Budget OIC Mr. Manolo M. Perlada, the additional honorarium is possible as there is enough fund, and it is included in the AIP 2022.

CHAIR: Thank you mam, can you give us a introduction ditto po sa hinihingi request ng Senior Citizens.

MS. J. DANGAL: Narito po ang aming kahilingan, Kapasyahang humiling sa minamahal na Punong Lungsod (refer to the attached copy), marami pong salamat.

CHAIR: Thank you mam Dangal for the introduction, questions from the committee on laws, Councilor Ched Atienza.

KAG. I. KAG. I. ATIENZA: Salamat po Budget Officer Manolo Perlada for enlightenment.

CHAIR: So clarification sir Manolo, so you're trying to say, kasi po working na po yong ating budget for the next calendar year, and ito po ay pag nagkaroon po ng resolution coming from the Sangguniang Panlungsod then we will be \_\_\_ to our local chief executive para po maisama don sa working proposed budget po natin, so siguro kung yon po yong 1<sup>st</sup> option but I think magkakaroon naman po siguro ng katuparan, kung hindi man po pwede naman pong maihabol sa supplemental, is that possible?

MR. M. PERLADA: Supplemental budget for the Calendar year po? Or the next 2022

CHAIR: Yes

MR. M. PERLADA: Medyo kaya naman po yan sa 2023 kasi sabi ko nga po, nasa preparation stage po tayo, sa budget cycle po natin itong period na ito ay tamang-tama para maihabol kung ano po yong mga gustong isama sa 2023 budget po.

CHAIR: Thank you sir Manolo,

KAG. N. DIMACUHA: Thank you Mr. chairman, the resolution approved and passed by the OSCA is very timely ano po, so we are now in the process of budgeting at nabanggit po ni Budget Officer na si Ginoong Perlada na once approved by the Sangguniang Panlungsod ay iko-consider po ito sa Annual Budget, sa Fiscal Year 2023, however, there is a suggestion na perhaps you could consider that this request, doon sa kung sakaling magkakaroon tayo ng supplemental budget ano po, yon po naman ang suggestion ng ating chairman of the committee on appropriations, ano po, so I would like to raise with the same question, would it be possible to include that in our supplemental budget para magkaroon po tayo ng malinaw na kasagutan.

MR. M. PERLADA: Mr. Chair, yon po yong sinasabi ko kanina, I was asking if this 2022 or 2023, kung 2022 po at medyo maluwag po yong supplemental budget since ang bibigyan lang po naman natin diyan ng increase ay kung kailan po ma-approve yong supplemental budget at saka itong authority na ito, so most likely, nasa apat na buwan na lang po ang natitira natin for 2022, magagawan naman po ng paraan yan.

KAG. N. DIMACUHA: Okey, follow up question, ano po, we have here in our possession the copy of the Supplemental Annual Investment Plan ano po, sabi ko nga ano, very timely ang kanilang request and if we could discuss in the provisions of the supplemental Annual Investment Plan, as \_\_ the manual wala po akong nakitang karagdagan or supplemental funding apra sa senior citizens, so yong question ko pa mamaya ay ngayon ko na rin ikukuwestiyon say o, considering na ito naman ay supplemental din ang hinihingi so itatanong ko na rin sa inyo kung possible mainclude natin ito sa Supplemental Annual Investment Plan No. 1 ano po.

CHAIR: You may answer sir.

MR. M. PERLADA: Ang program po natin for the elderly is already included in the Annual Investment Plan of 2022 po.

KAG. N. DIMACUHA: yes in annual ano

MR. M. PERLADA: Opo

KAG. N. DIMACUHA: Sabi ko nga po

MR. M. PERLADA: Provided po ng senior citizens \_\_\_\_, the amount approved in the AIP pwede po iyon.

KAG. N. DIMACUHA: yes, okey, so meaning to say, \_\_ sa annual investment plan natin at to \_\_ ay iimplement natin ito, however yon nga po ang question kanina, the fund kung sakali ay meron at possible naman na maibigay doon sa o maisama sa papasok na supplemental budget, supplemental budget malinaw po. Okey thank you

CHAIR: Thank you Konsehal Boy, Coucnilor Hamilton Blanco, you're now recognized

KAG. H. BLANCO: Thank you Mr. Chair, Mr. Chair, tanong ko lang po sa kanina sa sinasabi po ni mam Dangal na kapasyahan na humihingi ng kapahintulutan sa ating kagalanggalang City Mayor Bev na madagdagan ng karagdagang 1,500 ang natatanggap na honoraria ng mga OSCA President sa one hundred five barangays, itatanong ko laang ho Mr. Chair, buong Board ng hundred five barangay po yong nagtulungtulung for clarification lang po para don sa kapasyahan ng 1,500 additional na honoraria, tama po?
