**ORDINANCE NO. 22-02 S. 2023**

**AN ORDINANCE EXTENDING THE DEADLINE FOR SUBMISSION OF APPLICATIONS FOR BUSINESS PERMITS AND PAYMENT UNTIL FEBRUARY 15, 2023, WITHOUT PENALTIES**

**WHEREAS**, Ordinance No. 19 S. 2008, as amended, otherwise known as "AN ORDINANCE ADOPTING THE BATANGAS CITY REVENUE CODE OF 2009", specifically Section 9 thereof, prescribes the time of payment of all local taxes, fees, or charges which shall be paid within the month of January or on the first month of the subsequent year, as the case may be;

**WHEREAS**, the Sanggunian concerned may, for justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six (6) months;

**WHEREAS**, the country is still in continuous battle against the threat of the COVID-19 pandemic and the health and safety protocols are still observed;

**WHEREAS**, it is necessary to have an extension of deadline for the submission of applications for business permits and payment until February 15, 2023 without incurring any interest, penalty or surcharges for the Current Year 2023;

**NOW THEREFORE, be it ORDAINED** as it is hereby **ORDAINED** by the Sangguniang Panlungsod of Batangas City in a session duly assembled the following:

**SECTION 1. Coverage** - This Ordinance applies only to the extension of deadline for the submission of application for business permits and payment of all local taxes, business permits, fees and charges payable at the City Government of Batangas for the year 2023 only.

**SECTION 2. Time for Payment** - All local taxes, fees or charges for the year 2023, shall be payable up to February 15, 2023. The Sanggunian concerned may, for justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months.

**SECTION 3. Applicability** - The provisions of this Ordinance as regards the extension for the payment of all taxes, business permits, fees and charges shall be applicable for taxable year 2023 only. The deadline of payment provided under the Revenue Code of Batangas City which is within the month of January or on the first month of the subsequent year shall be in effect in the taxable years thereafter.

**SECTION 4. Separability Clause** - If for any reason, any part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.
