ORDINANCE NO. 22-03 S. 2023

**AN ORDINANCE ADOPTING THE OFFICIAL LOGO  
OF THE BATANGAS CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE**

**AUTHORED BY: COUN. NELSON J. CHAVEZ**

**WHEREAS**, Executive Order No. 138 otherwise known as "Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for Other Purposes" recognized that with the full devolution of the provision of basic services and facilities to the LGUs, national government agencies can assume more strategic and steering functions to address persistent development issues;

**WHEREAS**, the Office of the City Social Welfare and Development is the local government agency whose primary mandate is to provide basic social services to the constituency, thereby, its functions and facilities are effectively devolved to the local government of Batangas City;

**WHEREAS**, in line with the devolution of functions of the DSWD to the Local Government Unit, the CSWDO is advised to adopt its own Official Logo, compliance thereto requires an ordinance.

**NOW THEREFORE**, be it Ordained by the Sangguniang Panlungsod in session assembled:

**SECTION 1. PURPOSE.** - This Ordinance aims to adopt the Official Logo of the Batangas City Social Welfare and Development Office which shall be present the face of the CSWDO and visually communicate the unique identity of the Office and its vision, mission, and goal.

**SECTION 2. OFFICIAL LOGO.** - The Office of the City Social Welfare and Development Office hereby adopts the following Official Logo, and the interpretation of the Logo's symbolism:



**Red Heart** - represents the red heart of the personnel to serve the needy families of the City;

**Blue hands in praying position** - represents the helping hands of the government and its efforts for the fulfillment of the purpose to uplift the conditions and meet the needs of the constituents, especially those who most need assistance;

**AN ORDINANCE ADOPTING THE OFFICIAL LOGO OF THE BATANGAS CITY  
SOCIAL WELFARE AND DEVELOPMENT OFFICE**

**Yellow and blue borderline** – represents an enclosure around the City Government, service providers, stakeholders, and the people helping each other for the betterment of the society through service, and for attaining the vision, mission, and goal of the government to alleviate poverty.

**SECTION 3. AUTHORITY.** – The Office of the City Social Welfare and Development Office is hereby authorized to use the Official Logo illustrated and described under the preceding Section in the discharge of its official duties, functions, and activities.

**SECTION 4. SEPARABILITY CLAUSE.** – If any provision or part hereof is held invalid or unconstitutional, the provisions not otherwise affected shall remain valid and existing.

**SECTION 5. REPEALING CLAUSE.** – All ordinances, orders, rules and regulations or other issuances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE.** – This Ordinance shall take effect after approval by the City Mayor and completion of publication in a newspaper of general circulations in the Cities and Province of Batangas.



**SUBJECT: Request of the CSWDO Mila M. Española for authority to adopt and use its own Logo**

Referred to the Committee is the request of the City Social Welfare and Development Officer, Mila M. Española for authority to adopt and use its own Logo.

The Committee held a Committee Hearing on January 31, 2023. The members of the Sangguniang Panlungsod, CSWDO Mila M. Española, and City Legal Office representative Ms. Caroline Gaba were in attendance.

The request of the City Social Welfare and Development Officer is based on the advice of the Department of Social Welfare and Development Office that the local CSWD must adopt its own Official Logo, relative to the implementation of the full devolution of functions of the department to the LGU.

The CSWD attached its proposed official logo and presented the following interpretation and symbolism:



**Red Heart** – represents the red heart of the personnel to serve the needy families of the City;

**Blue hands in praying position** – represents the helping hands of the government and its efforts for the fulfillment of the purpose to uplift the conditions and meet the needs of the constituents, especially those who most need assistance;

**Yellow and blue borderline** – represents an enclosure around the City Government, service providers, stakeholders, and the people helping each other for the betterment of the society through service, and for attaining the vision, mission, and goal of the government to alleviate poverty.

After deliberation, the Committee finds that the request of the CSWDO is valid and necessary. There is no legal impediment in granting the requested authority.
