AN ORDINANCE RATIFYING THE EXPENDITURES OF ER 1-94 FOR 2021 AMOUNTING TO ONE HUNDRED FIFTEEN MILLION, ONE HUNDRED SEVENTY FIVE THOUSAND, THREE HUNDRED TWENTY SEVEN PESOS AND FIFTY FIVE CENTAVOS (Php 115,175,327.55) FOR COVID-19 RESPONSE AND OTHER COVID-19 RELATED PROGRAMS OF BATANGAS CITY

SECTION 2. REPEALING CLAUSE. – All ordinances, rules and regulations, orders or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE- If for any reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY- This Ordinance shall take effect upon approval of the City Mayor.
