These barangay budgets are therefore considered operative and effective as of January 1, 2014 in accordance with Section 332 of R.A. 7160.


Certified copy of this resolution shall immediately be furnished to the concerned Sangguniang Barangay, through its Punong Barangay, and to the City Budget Officer.
