RESOLUTION NO. 28 S. 2014

DISAPPROVING BARANGAY ORDINANCE NO. 01-14 OF BARANGAY CALICANTO,
OTHERWISE KNOWN AS "PAGPAPABUWIS SA LAHAT NG NEGOSYO AT GAWAIN
AT ANG PAGPAPAKUHA NG MGA CLEARANCE SA MGA NAGTATRABAHO
SA NASASAKUPAN"

WHEREAS, a judicious review, evaluation and analysis of the barangay ordinance submitted before the Sangguniang Panlungsod for review shows that the same subject ordinance did not show substantial compliance with existing laws, rules and regulations,

WHEREAS, said subject ordinance submitted for review fail to show the Sangguniang Panlungsod justification as to reasonableness of the cost of barangay clearance in their barangay ordinance;

NOW THEREFORE, be it resolved as it hereby resolves, to disapprove and declare inoperative Barangay Ordinance No. 01-14 of Barangay Calicanto, submitted for review, without prejudice for the said barangay to review and legislate a similar ordinance bearing in mind the recommendation and findings of the Joint Committee on Barangay Affairs and Laws, Rules and Regulations.

RESOLVED FURTHER, that the Joint Committee on Barangay Affairs and Committee on Laws, Rules and Regulations provide assistance in whatever capacity it can to enable the said barangay to pass another similar ordinance in the future;


