**WHEREAS**, as Batangas City Government is the owner of the

Diversion Road Alangilan, Batangas City;

**WHEREAS**, the Beredo family is an owner of a property/ies  
located at the back of the Batangas City Grand Terminal;

**WHEREAS**, there is no other access or right-of-way available  
and less burdensome than that at the side of the Batangas City  
Grand Terminal;

**WHEREAS**, it is the obligation of the Batangas City  
Government to grant an easement of the right-of-way.

authorize the Batangas City Government to grant a right-of-way

Batangas City this 20<sup>th</sup> day of January, 2014."


