RESOLUTION NO. 197 S, 2015

A RESOLUTION RECOMMENDING THE ADOPTION OF EMPOWERMENT AND REAFFIRMATION OF PATERNAL ABILITIES TRAINING (ERPAT) IN THE CITY OF BATANGAS

WHEREAS, under Section 458 (a) of the Local Government Code of 1991 the Sangguniang Panlungsod as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of the said code including Barangay Officials of the City;

WHEREAS, the program of organizing women groups known as KALIPI in Batangas City is a successful program implemented by the City not to mention all the activities launched thru the initiative of CSWDO under the City Mayor's Office;

WHEREAS, the community especially in Batangas City believes that the role of fathers in nurturing of children just as important as that of mothers;

WHEREAS, in our new generation and global economic slowdown, many mothers are constrained to work outside the home; hence, the support of fathers in the rearing of children has become even more significant;

WHEREAS, the Department of Social Welfare and Development (DSWD) recognizes the significant role of fathers in child care and contribution to familial tasks. Fathers should be viewed not only as providers but also as active partners in child rearing. If their nurturing capabilities are harnessed and strengthened, we are certain that they will contribute favorably in promoting and supporting the physical, emotional, social and intellectual development of their children;

WHEREAS, DSWD's Social Technology Bureau in 2014 developed the Empowerment and Reaffirmation of Paternal Abilities (ERPAT) program which aims to discuss with fathers their changing role as head of the family, improve men's parenting skills through seminars that tackles the role and attitude of father, raising and understanding the needs of children and knowing the differences between men and women, among others;

Dimacuha and City Social Welfare and Development Office thru Mrs. Mila Española to review the adoption of Empowerment and Reaffirmation of Paternal Abilities Training (ERPAT) in the City of Batangas.
