**RESOLUTION APPROVING THE CONTRACT AND GRANTING AUTHORITY TO THE

FOR THE DESIGN AND BUILD OF CALUMPANG BRIDGE NO. 3**

**WHEREAS**, on October 19, 2015, the Honorable City Mayor requested for the approval of the contract and granting authority to sign the contract agreement with the FREY-FIL CORPORATION;

**WHEREAS**, the City Mayor needs an authority to sign the contract agreement for the Design and Build of Calumpang Bridge No. 3;

**WHEREAS**, the Sangguniang Panlungsod takes notice of the ongoing consultation between the Office of the City Mayor and affected residents of Sitio Ferry and Gulod Labac in relation to the acquisition of road right of way for the proposed project;

**WHEREAS**, the second party shall submit to the City Mayor copy furnished the Sangguniang Panlungsod the plans, specifications, as stated in Section 2 of the contract before the announcement of the construction of third bridge project;

**WHEREAS**, the submitted terms of reference and design and build are hereby made integral parts of the contract and strict compliance with these are hereby mandated.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to approve the contract and to grant authority to the City Mayor to sign the contract agreement between the City Government of Batangas and FREY-FIL Corporation.




Finding no legal impediment with the subject, and finding that the construction of Third Bridge would be beneficial to the City Government and to its inhabitants, the Committee recommends:
