**WHEREAS**, the Batangas City Leadership commits to provide its people with a peaceful and safe environment conducive for healthy and sustainable development;

**WHEREAS**, in pursuit of this commitment, the City Government strives to rally its team and encourage its members towards effective service;

**Continuation of Resolution No. 410 S. 2015**




