RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF AGRICULTURE AND THE CITY GOVERNMENT OF BATANGAS REGARDING THE FARM MECHANIZATION AND EXPANSION PROJECT 2016 –BOTTOM-UP BUDGETING

WHEREAS, the Aquino Administration shall pursue the Philippine Millennium Development Goal (PMDG) of reducing poverty from 33.1% in 1991 to 16.6% by 2015. This is likewise reflected in Executive Order No. 45, Series of 2011 and the Philippine Development Plan for 2011-2016;

WHEREAS, Executive Order No. 43 Series of 2011 enjoins all department and agencies to orient their programs, projects and activities towards the pursuit of five (5) Key Results Areas that include Poverty Reduction and Empowerment of the Poor and Vulnerable;

WHEREAS, a well thought strategy to reduce poverty incidence in the country is the implementation of Bottom-up Budgeting (BuB) that aims to ensure the inclusion of the funding requirements for the development needs of the poorest municipalities and cities in the program and budgets of National Government Agencies (NGA).

WHEREAS, the Department of Agriculture (DA) is one of the NGAs participating agencies as identified in the DBM-DILG-DSWD-NAPC JMC No. 7, Series of 2015 dated November 3, 2015 re: Policy Guidelines and Procedures in the Implementation of the Bottom-up Budgeting Projects for Fiscal Year 2016;

WHEREAS, the DA-RFOIV-A supports and undertakes activities to assist and promote the development of the agriculture and fishery post harvest industries in the countryside;
