RESOLUTION NO. 100 S. 2017

DESIGNATING COUNCILOR AILEEN GRACE A. MONTALBO TO PERFORM THE DUTIES AND FUNCTIONS OF THE OFFICE OF THE VICE MAYOR DURING THE PERIOD OF LEAVE OF ABSENCE OF THE CITY VICE MAYOR

WHEREAS, the **HONORABLE EMILIO FRANCISCO A. BERBERABE, JR.**, City Vice Mayor OF Batangas City, shall go on leave of absence from May 18, 2017 to June 21, 2017 for the purpose of travel outside the country;

WHEREAS, there is a need to designate an officer to discharge the duties and functions of the Office of the Vice Mayor during the temporary absence of the Vice Mayor;

WHEREAS, the law provides that in case of temporary physical legal vacancy of the Office of the Vice Mayor, for reasons such as, but not limited to, leave of absence or travel abroad, the highest ranking member of the Sangguniang Panlungsod shall assume Office and perform its duties and functions until the Vice Mayor reports back to office;

WHEREAS, Councilor Aileen Grace A. Montalbo is the highest ranking incumbent member of the Sangguniang Panlungsod of Batangas City;

NOW THEREFORE, be it resolved by the Sangguniang Panlungsod in session assembled, to resolve, as it hereby resolves to designate, as it hereby designates **HONORABLE AILEEN GRACE A. MONTALBO** to perform the duties and functions of the Office of the City Vice Mayor for the period covering the Leave of Absence of Vice Mayor Emilio Francisco A. Berberabe, Jr. from May 18, 2017 to June 21, 2017;

RESOLVED FURTHER, that this designation serve as a grant of authority to Councilor Aileen Grace A. Montalbo to sign documents, checks and other papers necessary for the efficient discharge of functions of the Office of the Vice Mayor, subject to existing laws, rules and regulations, and limitations thereof.


