RESOLUTION NO. 168 S. 2017

**A RESOLUTION RECOMMENDING THE ISSUANCE OF A CEASE AND DESIST ORDER
FOR THE CONSTRUCTION OF DRAINAGE AT GULOD LABAC,
BATANGAS CITY**

WHEREAS, the Sangguniang Panlungsod received several complaints concerning the on-going construction of drainage along Governor Carpio Road, Gulod Labac, Batangas City;

WHEREAS, the on-going construction has resulted to various vehicular accidents and have imperiled lives and properties of commuters and pedestrians alike;

WHEREAS, the construction is being undertaken by the Great Swiss Metal Builders Corporation;

WHEREAS, there is a need to discontinue the construction until the contractor has ensured compliance with the safety and requirements of the law;


NOW THEREFORE, be it resolved as it is hereby resolved, by the Sangguniang Panlungsod in session assembled, to recommend to the City Legal Officer to issue a Cease and Desist Order to the Great Swiss Metal Builders, Corporation, contractor of the on-going construction of drainage at Gulod Labac, Batangas City the soonest time possible.
