

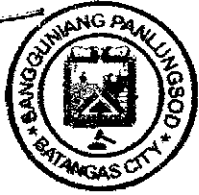

COMMITTEE REPORT

SUBJECT : Letter from the Honorable City Mayor, Beverley Rose A. Dimacuja requesting for the passage of a resolution granting the City Mayor the authority to enter into a service agreement with Batangas Diagnostic Medical Imaging Center Inc. for the use of BDM's diagnostic facilities and services.

**COMMENTS/ RECOMMENDATION:**

Referred to the Joint Committee of the Committee on Laws, Rules and Regulations and Committee on Health is the above request for study, comment and recommendation.

A hearing was conducted on June 21, 2017 attended by the Acting Chairman and members of the committee and other members of the Sangguniang Panlungsod. Also present were City Health Officer Dr. Rosanna Carmelita A. Barrion, BDM Medical Director Eugene C. Dy and representative from City Mayor's Office Mr. Manolo M. Perlada.

The City Government of Batangas, as part of its health program, requires the use of diagnostic facilities and services. While, Batangas Diagnostic Medical Imaging Center Inc. is engaged in providing Magnetic Resonance Imaging (MRI) and Computed Tomography (CT Scan) diagnostic services to patients of the Local Government of Batangas.

Furthermore, the procedural aspect of the subject matter prior to the grant of such requested authority was discussed since it was the concern of some members of the Sangguniang Panlungsod. Although the concern was clarified and explained by the City Health Officer and the representative of the City Mayor, the committee sought the legality of the concern to the City Legal Office that led to the issuance of the attached legal opinion as an integral part of this report.

Since the City Legal Officer opined that the City Government of Batangas is not under obligation to pay anything to the Batangas Diagnostic Medical Imaging Center Inc. and that there is no need to appropriate any money for the services rendered by the Center, the Committee hereby recommends:

1. The adoption of this Committee Report
2. The approval of the required Resolution hereto attached.
