
RESOLUTION NO. 181 S. 2017

**RESOLUTION CLEARING THE NAME OF MS. MICHELLE SANDRA  
MAGHIRANG FROM THE ALLEGED COLLECTION OF ILLEGAL FEES  
FROM PUPILS OF KUMINTANG ELEMENTARY SCHOOL**

**WHEREAS**, the Committee on Education was lodged with a concern raised by Honorable Councilor Nestor Dimacuha regarding the alleged collection of contributions in Kumintang Elementary School;

**WHEREAS**, a hearing was conducted on June 21, 2017 to discuss the surrounding issues of the aforementioned allegation in Kumintang Elementary School attended by members of the Committee on Education, other members of the Sangguniang Panlungsod, members of the Department of Education, Batangas City, officials and teachers of Kumintang Elementary School, barangay officials of Kumintang Ilaya, Kumintang Elementary School Parent Teachers Association Officers and a parent from Kumintang Elementary School among others;

**WHEREAS**, it was verified during said hearing that a misunderstanding between Kumintang Elementary School Officials and the Teacher's Association occurred as to who is authorized to collect the voluntary contributions from students to help those who cannot afford to purchase their own IDs;


**WHEREAS**, it was likewise verified that it is not Ms. Michelle Sandra Maghirang who is collecting said voluntary contributions but the Vice President of Kumintang Elementary School's Parent Teachers Association;

**WHEREAS**, it was agreed by parents, officers of the Parent Teacher's Association, officials of Kumintang Elementary School, Barangay Officials of Kumintang Ilaya and all others concerned that the matter be clarified to all parents and to the community of Kumintang, to clear the name of Ms. Michelle Sandra Maghirang from the said allegation;

**NOW THEREFORE, BE IT RESOLVED** as it is hereby resolved by the Sangguniang Panlungsod ng Batangas to clear the name of Ms. Michelle Sandra Maghirang from the alleged collection of illegal fees from pupils of Kumintang Elementary School.

**RESOLVED FURTHER**, that copies of this resolution be forwarded to the Honorable City Mayor of the City of Batangas, Department of Education, Batangas City, Kumintang Elementary School, Kumintang Elementary School's Parent Teacher's Association and Barangay Kumintang Ilaya.
