**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, BEVERLEY
ROSE A. DIMACUHA, TO SIGN AND ENTER INTO A MERCHANT AGREEMENT FOR AND
ON BEHALF OF THE CITY GOVERNMENT OF BATANGAS WITH THE DEVELOPMENT
BANK OF THE PHILIPPINES REGARDING POINT OF SALE SYSTEM FOR REGULAR ATM
DEBIT TRANSACTIONS/VISA CARD TRANSACTIONS**

WHEREAS, the Development Bank of the Philippines through its Point of Sale (POS) System, undertakes to make available to participating Cardholders, the opportunity to purchase or pay taxes and fees from various local government units;

WHEREAS, the City Government of Batangas is legally mandated to engage in business and to deliver specific services to the transacting public. It agrees to participate in the POS (Point-of-Sale) System Service of the DBP and to honor cards issued by the conditions specified under a draft Merchant Agreement;

WHEREAS, the DBP submitted a revised copy of the draft Merchant Agreement to be entered into by the City Mayor and DBP for and on behalf of the City Government of Batangas to the Sangguniang Panlungsod for its review and consideration;

WHEREAS, after thorough deliberation and examination of the ultimate goals in said request, the August Body find it proper to grant the same;


